Oakland Raiders NFL100 Season Ticket Experience Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN ANY PRIZE. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- **1. Deadlines:** To be eligible for any prize, you must submit a valid entry between June 17, 2019 and July 1st, 2019 at 11:59 PM PST.
- **2.
