

## Ravens Kickoff Kid Official Rules

### **NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASING WILL NOT INCREASE YOUR CHANCES OF WINNING.**

Void where prohibited or restricted by law, rule or regulation. This Sweepstakes is subject to all applicable federal, state, local laws, rules and regulations.

**1) Eligibility:** Ravens Kickoff Kid, presented by Wawa, (the “Sweepstakes”) is open to permanent legal residents of the fifty (50) United States and the District of Columbia who are 18 years of age or older at the time of entry and the parent or legal guardian of a child between the ages of 6 and 14 years old at the date of entry (each, an “Entrant”). Employees, officers and directors of the Baltimore Ravens Limited Partnership (the “Club”), Wawa, Inc. (“Sponsor”) and each of their respective parents, subsidiaries and affiliated companies, representatives, directors, officers, agents, divisions, dealers, affiliates, distributors, advertising and promotional agencies, employees and assigns, advertising, promotion and administrative agencies; and anyone else connected with the production and distribution of this Sweepstakes and their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related to any of the above-named entities (all of the aforementioned collectively referred to as the “Sweepstakes Entities”), are not eligible to participate or win. Only an individual meeting all eligibility requirements set forth in these Official Rules may participate in the Sweepstakes or win a prize. In the event of any conflict or inconsistency with any other advertising, promotional or other materials, these Official Rules shall govern. The Club reserves the right to verify the eligibility of any winner before awarding any prize.

**2) Promotion Period:** Sweepstakes begins on Monday, July 23, 2019 at 9:00 a.m. Eastern Time (“ET”) and ends on Friday, December 20, 2019 at 11:59 p.m. ET (hereinafter, “Promotion Period”). The Promotion Period is divided into ten (10) entry periods (each a “Weekly Entry Period”) as outlined in paragraph 4 below. There will be one (1) drawing during each Weekly Entry Period. The Club’s computer is the official time keeping device for this Sweepstakes.

**3) To Participate:** There are two ways to enter during the Promotion Period:

a) **Online:** Visit [baltimoreravens.com/kickoffkid](http://baltimoreravens.com/kickoffkid) during the Promotion Period and follow the instructions provided to enter the code to receive one (1) entry; OR

b) **Mail-In:** Hand print your name, complete mailing address, telephone number, date of birth, email address and the words “Ravens Kickoff Kid” on a plain piece of paper and mail it in an envelope with proper postage affixed to: Ravens Kickoff Kid, 1 Winning Drive, Owings Mills, MD 21117 to receive one (1) entry (online entries and mail-in entries shall be collectively referred to as an “Entry”).

**Limit of one (1) Entry per person per Weekly Entry Period throughout the Promotion Period regardless of method of Entry.** Additional Entries received from the same natural person in excess of the stated limitation will be void. All entries become the exclusive property of the Club and will not be acknowledged or returned. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of Entry) to enter the Sweepstakes is prohibited and any Entry through such means and any Entry that is deemed to be ineligible (at Club’s sole discretion and in accordance with these Official Rules) are void. In the event of a dispute as to the identity of an Entrant based on the email address submitted, the Entry will be deemed to be submitted by the person named on the applicable Entry (regardless of whether that is the name of the authorized account holder of the email address from which said Entry form was submitted), provided such individual is eligible according to these Official Rules.

The Club and Sponsor are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, damaged, illegible, inaccurate, postage due or undelivered Entries or mail, or for telephonic, human or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment,

programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of Entries, mail, or the announcement of the prize; or for any injury or damage to participant's or any other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. The Club reserves the right, in its sole discretion, to void any Entries of Entrants whom Club believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes or is in violation of these Official Rules.

**4) Drawing:** For each Weekly Entry Period, one (1) random drawing will be conducted on or about the date specified below by an authorized representative of the Club to select the winner from among all eligible Entries received by the Club for the corresponding Weekly Entry Period, whose decisions are final on all matters relating to this Sweepstakes. Odds of winning a prize will depend upon the total number of eligible Entries received. Potential prize winners will be notified by email, telephone, overnight delivery and/or mail (the "Notification") and may be required to complete, sign and return an Affidavit of Eligibility and Publicity/Liability Release prior to the receipt of the prize, or the prize may be forfeited and awarded to an alternate winner. If the potential winner cannot be contacted; is ineligible according to these Official Rules; fails to return the required documents within the specified time period; declines his/her prize for any reason whatsoever; otherwise fails to fully comply with these Official Rules; or if prize Notification is returned as undeliverable, potential prize winner will forfeit his/her prize and the prize may be awarded to an alternate winner from among all remaining eligible Entries received, in the Club's sole discretion. **5) Prizes:** Ten winners (each, a "Prize Winner") will be drawn over the 10 Weekly Entry Periods (one Prize Winner drawn from each Weekly Entry Period) will receive four (4) tickets to one (1) Ravens home game during the 2019 regular season (each, a "Game"), four (4) field passes for a pregame experience and one (1) Ravens youth jersey. (all of the aforementioned are collectively referred to as the "Prize"). Each Weekly Entry Period Prize Winner shall have the right to designate an eligible child between the ages of 6 and 14 at the time of Entry as a "Kickoff Kid" at the Baltimore Ravens home game listed above for the applicable Weekly Entry Period. The Prize Winner must be the parent or legal guardian of the Kickoff Kid and accompany the Kickoff Kid to the applicable Ravens home game (i.e. one ticket will be used by the parent or guardian of the Kickoff Kid, one ticket will be used by the Kickoff Kid, and the potential Prize Winner

can select who will use the two other tickets). Approximate Retail Value (“ARV”) of Prize: \$550 and total value of all Prizes is \$5,500. Travel and accommodations and any other costs associated with attendance at the Baltimore Ravens home football game shall be the sole responsibility of the potential Prize Winner. All Prize details are at Club’s sole and absolute discretion.

**6) Prize Restrictions:** No transfer, assignment, sale, duplication, cash redemption or substitution of Prize (or portion of Prize) is permitted, except by Club, which reserves the right to substitute a Prize (or applicable portion of Prize) with one of comparable or greater value, as determined by Club. Club is not responsible for and will not replace lost or stolen Prize or any component thereof. Non-compliance with these Official Rules may result in disqualification and, at Club’s sole discretion, the awarding of prize to an alternate Prize Winner. Prize Winner is solely responsible for any and all applicable fees, taxes and expenses associated with a Prize that are not specifically listed herein.

Additional terms, restrictions, and exclusions may apply to Game Tickets; see front and back of Game Tickets for additional terms and exclusions. All Game Tickets are subject to verification and are void and will be rejected if not obtained through authorized, legitimate channels, or if any part of any Game Ticket is determined by Club or Club’s agent or representative (including but not limited to a Baltimore Ravens employee or contractor) to be illegible, forged, reproduced, manipulated, mutilated, counterfeited, or tampered with in any way, or if Game Ticket contains printing, typographical, mechanical, or other errors.

In the event that the Game or any part of it is cancelled, postponed or preempted for any reason, including weather, no rain checks, exchanges, substitution or cash replacement value of the Prize will be provided except at Club’s discretion. In the event Prize Winner and/or Prize Winner’s guest at the Game (“Guest”) engages in behavior during the Game that (as determined by Club in its sole discretion) is obnoxious or threatening, illegal, or that is intended to threaten or harass any other person, or that in any way disparages or adversely affects the reputation, image, and/or customer goodwill of Club or any of Club’s services, products, trademarks, service marks, or logos, Club reserves the right to terminate Prize redemption and eject Prize Winner and/or Guest from the Game with no further obligations or compensation whatsoever to Prize Winner and/or Guest (which may, in Club’s sole discretion, result in such Prize Winner’s disqualification from the Sweepstakes and forfeiture of the Prize). **9) General Conditions:** Club reserves the right, in its sole discretion, to modify, suspend or terminate this Sweepstakes (or any portion thereof) should any virus, bug, fraud, non-authorized human intervention

or other causes, including but not limited to weather, war or armed conflict (whether or not officially declared), labor controversy or threat thereof, and/or acts of God, corrupt or impair the administration, security, fairness or proper play of this Sweepstakes and, in the event of termination, at its discretion, select Prize Winner from among all eligible, non-suspect Entries received as of the date of the event requiring such termination. Club reserves the right to disqualify any individual it determines, in its sole and absolute discretion, is or is attempting or intending to: (a) tamper with any aspect of the operation of the Sweepstakes, (b) defraud Club, (c) undermine the legitimate operation of the Sweepstakes by cheating, deception, or other unfair playing practices, (d) annoy, abuse, threaten, or harass any other participants, the Club, Sponsor, or representatives of the Club or Sponsor, or (e) act in violation of these Official Rules. In such event(s), Club reserves the right (in addition to disqualification of such individual) to seek damages from any such person to the fullest extent permitted by law. Club's failure to enforce any provision of these Official Rules shall not constitute a waiver of that provision. No groups, clubs, newsletters, or organizations may reproduce or distribute any portion of these Official Rules to their members, and anyone who participates in the Sweepstakes through means not permitted by these Official Rules is subject to disqualification. No more than the stated number of Prizes will be awarded.
