

Baltimore Ravens “You Pick the Team” CONTEST ("Contest") OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

The Contest is sponsored and administered by Baltimore Ravens Limited Partnership, One Winning Drive, Owings Mills, MD 21117 (“Sponsor”). The National Football League is neither a sponsor of, nor a partner in, this Contest.

1. To Enter: Between July 25, 2019 at 9:00 a.m. Eastern Time (“ET”) and August 30, 2019 at 12:00 p.m. ET ("Contest Period"), log onto baltimoreravens.com/youpicktheteam or visit the You Pick The Team page in the Ravens mobile app and follow the directions provided to submit the names of the players you think the Baltimore Ravens will pick to make their 53-man active roster by 12:00 p.m. EST on August 30, 2019. The list of available players from which to choose will be listed on baltimoreravens.com/youpicktheteam and on the You Pick The Team contest page in the Ravens mobile app, and will be updated when the Baltimore Ravens make a change to the roster. Entries must be received by August 30, 2019 at 12:00 p.m. ET to be eligible.

Only one (1) entry per person per email address will be accepted. If multiple entries are received from one person or email address, the first entry received will be deemed to be the only entry recognized for that person, email address or household and all other entries will be void.

Use of any device to automate entry or any other activity which subverts the entry process is prohibited and all such entries will be deemed void. The Sponsor will not verify receipt of entries. All entries submitted become the property of the Sponsor and will not be returned.

2. Winner Selection: One (1) potential Grand Prize winner will be determined by the sponsor on or about September 2, 2019 from all eligible entries received. The potential Grand Prize winner will be deemed the individual who submitted the eligible entry that most closely matches the Ravens official 53-man active roster, as determined by the Baltimore Ravens on September 1, 2019.

In the event of a tie, the entry that was received first, as determined by the sponsor in its sole discretion, will be deemed the winning entry. In the event that the earliest-received winning entries were received at exactly the same time, then the Sponsor will utilize a random drawing to select a winner from such winning entries.

3. Grand Prize: Lunch for the contest winner and one (1) guest with Ravens General Manager Eric DeCosta and tour of the Under Armour Performance Center at 1 Winning Drive, Owings Mills MD, 21117. And one (1) Marquise Brown autographed football. Approximate Retail Value (“ARV”): \$200. Date & time of lunch and tour to be mutually determined between sponsor and contest winner. All prize details are at Sponsor’s sole discretion. Transportation to and from the Under Armour Performance Center and all other ancillary expenses are the responsibility of the winner.

The authorized account holder is the natural person who is assigned to the e-mail address by the Internet access provider or the domain associated with the submitted e-mail address. All federal, state, and local laws and regulations apply. If any of the following occur, then the potential winner will be disqualified and, at Sponsor's discretion, the runner-up may be notified: (a) potential winner fails to respond to telephone or e-mail notification within 3 days of date sent/called; (b) potential winner fails to return Affidavit/Release Documents by the specified date and/or time; (c) potential winner is found to be ineligible; or (d) potential winner does not comply with the Official Rules.
