

**Florida City Gas Presents  
Miami Dolphins Natural Gas Game Changer Sweepstakes**

**1. ELIGIBILITY:** The Miami Dolphins Natural Gas Game Changer Sweepstakes (“Sweepstakes”) is open only to legal residents of the state of Florida who are 18 years of age or older at the time of entry. Officers, directors, and employees of Sweepstakes Entities (as defined below), immediate family members (spouses and/or parents, children, and siblings, and their spouses, regardless of where they reside) and/or those living in the same household of such persons (whether or not related thereto) are not eligible to participate or win. **2. TO ENTER:** No purchase is necessary and a purchase does not increase chances of winning. The Sweepstakes begins at 10:00:00 AM ET on August 8th, 2019 and ends 11:59:59 PM ET on December 13th, 2019 (“Sweepstakes Period”). During the Sweepstakes Period the Sweepstakes may be entered via the Team website ([www.MiamiDolphins.com/FloridaCityGas](http://www.MiamiDolphins.com/FloridaCityGas)) by completing and submitting the online entry form, which includes providing your full name, date of birth, mailing address, email address and phone number. P.O. boxes are not permitted. Incomplete, late or non-conforming entries will not be accepted. Sponsor is not responsible for any change of email address and/or phone number of entrants that limit ability to contact entrants. In the event of a dispute as to any email address, the authorized account holder of the email address used to register will be deemed to be the entrant. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. Limit one (1) entry per person/email address, per day, during the Sweepstakes Period. Each winner will receive two (2) 100-Level tickets to the Miami Dolphins vs. Cincinnati Bengals game at Hard Rock Stadium currently scheduled to be played on December 22<sup>nd</sup> 2019 and will receive two (2) pre-game field passes for an on-field meet-and-greet with one (1) Dolphins alumni player. Approximate retail value of each prize is \$600.00. Approximate retail value of all prizes is \$3,000.00. Additional travel and accommodations are not included in the prize. Prize is non-transferable and non-refundable, and no substitutions by Entrants will be permitted. Sponsor reserves the right to substitute prize of

equal or greater value in the event of prize unavailability. Winner is solely responsible for all other expenses not specifically set forth herein, including but not limited to meals, transportation, souvenirs, room accommodations, and other incidentals and items of a personal nature. Sponsor is not responsible for lost, mutilated, or stolen travel documents. In no event will more than the stated number of prizes be awarded.

**4. SELECTION OF WINNERS:** Winners will be selected from among all eligible entries in random drawings within approximately two (2) days after Sweepstakes Period end date listed above. The drawings will be conducted by the Team, whose decisions are final on all matters relating to the drawings. Odds of winning depend on the number of eligible entries received. **5. WINNER NOTIFICATION:** Winners will be notified by phone or email, in Sponsor's discretion. The Winner is responsible for all federal, state and local taxes, if applicable. In addition, Sponsor will require winner(s) to complete, sign, and return a witnessed statement of Eligibility/Liability Release/Publicity Release forms, and other applicable documents, which may require Winner to provide social security number, within five (5) days of the date of the notification.
