#### III. The Game

# A. To Participate in the Game:

- (1) During the Promotion Period, open the Official New York Jets Mobile App ("App") and click on the "I Called It" button ("Promotion Button"). If you do not have the App, you can download it for free on the iOS and Android operating systems. After clicking the Promotion Button, you will need to confirm that you are twenty-one (21) years of age or older and, if a first-time user, complete the registration form to participate in the Promotion. Participants are responsible for ensuring that all required information is accurate. Limit one (1) registration form submission per person and per email address for the duration of the Promotion Period. Additional registration forms received from any such person or email address after the first registration form received from that person or email address will be void. b. In the event all of the above Predictions are answered for any given game, you will unlock one (1) additional bonus question (Prediction K). If you correctly make the Prediction K, you will receive the following points:

(3) Throughout the applicable Jets football game, make a prediction regarding the outcome of the first offensive possession by either team that begins from scrimmage in each of the four quarters of the game (i.e., not including possessions that carry over from the prior quarter or that consist solely of a return of an interception, fumble, kickoff, or punt) for a total of four (4) possible predictions. The Prediction will be about the outcome of the possession in question ("Prediction L"). If you correctly make a Prediction as outlined above, you will receive the following points:

You will only gain points for the correct Predictions submitted. If you a submit a Prediction and it does not happen, you will gain zero (0) points for that Prediction. The object of the Promotion, in each applicable week, is to earn the most possible points by correctly making Predictions as outlined above.

- (4) If a participant makes at least one Prediction in two or more consecutive weeks, such participant will automatically earn ten (10) bonus points for each consecutive week (i.e., two (2) consecutive weeks will equal 20 points, three (3) consecutive weeks will equal 30 points, etc.).

Ten (10) Prizes will be awarded, respectively, to the participants who accumulate the ten (10) highest numbers of valid points cumulatively for each regular season game, as determined by Sponsor in its sole discretion. # (1) Make a Prediction:

For each Prediction submitted (as described above), automatically receive one (1) entry into the Sweepstakes drawing. In the event all Predictions are made for each applicable game (as defined above), a maximum of two hundred and forty (240) Sweepstakes entries may be earned for the duration of the Promotion Period.

# (2) Alternate Entry:

To receive one (1) Sweepstakes entry without making a Prediction, hand print your name, complete mailing address, email address, telephone number and date of birth, and the words "I Called It!" on a plain 3" x 5" piece of paper and mail it in a <u>sealed</u>, stamped and hand printed #10 envelope to: Jets "I Called It" Entry, 1 Jets Drive, Florham Park, NJ 07932. **Enter up to 240** times by mail, but each entry must be mailed separately and received by 12/30/19.
