

Sweepstakes Official Rules

3. Open to legal residents of the United States 18 years or older at time of entry (each eligible person to enter is an "Entrant"). Employees of the Sponsor and its affiliates and subsidiaries; their advertising, promotion, and fulfillment agencies; and members of the immediate family or household of each of the above are not eligible to participate. Limit one entry per person; multiple entries will not increase chances of winning and may result in Entrant's entry being filtered out. Enter using only a valid email account held by Entrant.
