

**2020 TORO'S READING CHALLENGE CONTEST
PRESENTED BY FIRST COMMUNITY CREDIT UNION
OFFICIAL RULES**

1. **NO PURCHASE NECESSARY:** Void where prohibited. Subject to applicable federal, state and local laws.

2. **ELIGIBILITY:** Contest is open only to legal residents of the United States who are 18 years of age or older and are the parent or legal guardian of a child under the age of eighteen (18) years of age. Employees of Houston NFL Holdings, L.P. (the "Texans"), the National Football League (the "NFL"), First Community Credit Union, and each of their respective subsidiaries, affiliates and advertising/promotional agencies, and the immediate families and household members of each, are not eligible.

3. **HOW TO ENTER:** To enter the Contest, entrants must do the following:

- a. Complete the registration form on HoustonTexans.com
- b. After completing the registration form, there will be two different ways to win:

Weekly Social Media Challenge

- Entrants will have the opportunity to participate in a fun challenge each week during April via social media.
- The details of the challenge will be communicated to the entrants via TORO's social media accounts such as @TexansTORO1.
- Only one (1) entry per weekly challenge

Reading Challenge for the Month of April

- Download the reading log provided by the Texans to track how long his/her child has been reading during the entry period.
- Complete the reading log and submit to the Texans via email at TORO@HoustonTexans.com before the end of the Entry Period.
- Only one (1) entry for the monthly challenge

4. **ENTRY PERIOD:** The entry period for the entire Contest will begin on March 30, 2020, when the Contest is launched on various Houston Texans media platforms and end at 12:00 p.m. on April 30, 2020. The entry period for each weekly challenge will be each Monday between 10:00am and 5:00pm.

5. **SELECTING THE WINNERS:**

Weekly Social Media Challenge

- A Texans employee will randomly select one (1) Social Media prize winner out of all eligible entries received at 5:00pm each Monday for a total of four (4) Social Media prize winners.

Reading Challenge for the Month of April

- A Texans employee will randomly select five (5) Grand Prize winners that completed the Reading Challenge at the end of the Entry Period out of all eligible entries received.

Entrants are eligible to win one or more Weekly Social Media Challenges as well as the Reading Challenge for the Month of April. The Houston Texans will contact the winners via email and/or phone number provided upon contest entry.
