

## 2020 Carolina Panthers Draft Lounge: Home Edition RSVP Sweepstakes

### Official Rules

#### **NO PURCHASE NECESSARY TO ENTER OR WIN.**

**1) Eligibility:** The 2020 Carolina Panthers Draft Lounge: Home Edition RSVP Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of the fifty (50) United States or District of Columbia who, prior to 4/21/20 are twenty-one (21) years of age or older (hereafter, "Eligible Entrants"). **2) Promotion Period:** Sweepstakes starts 10:00:00 am Eastern Time ("ET") on 4/21/20 and ends at 7:30:00 pm ET on 4/23/20 (hereafter, "Promotion Period").

**3) How to Enter:** During the Promotion Period, visit [Panthers.com/Draft](http://Panthers.com/Draft) and complete and submit the registration form to receive one (1) entry.

Entries must be received by 7:30:00 pm ET on 4/23/20 to be eligible. **Only one (1) entry per person will be accepted throughout the Promotion Period. Entries received in excess of the stated limitation will be void.** All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor's sole discretion and in accordance with these Official Rules) are void. other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. The potential winners will be notified by telephone and/or email and may be required to execute and return an Address Verification Form within two (2) days of date of issuance of notification. Non-compliance with the foregoing, with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner.

Exact details surrounding the Grand Prize including, but not limited to, exact Draft pick and duration of message is at Sponsor's sole discretion. **One (1) First Prize:** The First Prize winner will receive one (1) Jake Delhomme football. ARV: \$150. Autographed item is not game used/worn. Actual value of autographed item is subject to market fluctuations. No Certificate of Authenticity is provided by Sponsor. **One (1) Second Prize:** The Second Prize winner will receive one (1) Carolina Panthers prize pack. ARV: \$50. Exact items in prize pack are at Sponsor's sole discretion.

All prize details are at Sponsor's sole discretion. Prizes are awarded "as is" without any warranty or guarantee, either express or implied by Sponsor. Costs and expenses associated with the acceptance and use of a prize not specified herein as being awarded, including, but not limited to, federal, state and local taxes (if any) are each winners' sole responsibility. **6) Miscellaneous:** No transfer, assignment, cash redemption, or substitution of a prize is permitted except by Sponsor who reserves the right to substitute a prize (or applicable portion thereof) with one of comparable or greater value, at its sole discretion. Entrants agree, by entering, that 1) Sponsor and its designees may use (unless prohibited by law), entrant's name, city and state of residence, photograph and/or likeness for advertising, trade and/or any other purposes in any media now or hereafter known throughout the world in perpetuity, without further compensation, permission or notification, 2) Sponsor reserves the right to conduct a background check and entry in the Sweepstakes constitutes entrant's permission for Sponsor to conduct such background check, provided that, to the extent additional authorization is necessary under law, entrants shall authorize such check. Sponsor reserves the right (at its sole discretion) to disqualify any entrant based on the results of the background check or failure of the entrant to properly authorize such
