

Sweepstakes Official Rules
NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Participation constitutes your (Entrant's) full and unconditional agreement to and acceptance of these Official Rules. The information in Rule No. 2 outlines the specifics for this Sweepstakes.
2. **Name of Sweepstakes:** Virtual 50 Yard Finish Giveaway
Sweepstakes Period: Begins 12:01am on June 27, 2020 and ends 11:59pm on June 27, 2020 or ends when the last prize is awarded, whichever occurs first.
Drawing Dates: Throughout the day on June 27, 2020
Prize Description: Autographed Buffalo Bills merchandise
Quantity and Value of Prizes to be Given Away: Three (3) Winners; Each prize has an approximate value of no more than \$50.
Sponsor(s): Buffalo Bills, LLC, One Bills Drive, Orchard Park, NY 14127 (the "Bills")
3. Open to legal residents of the United States residing in New York State 18 years or older at time of entry (each eligible person to enter is an "Entrant"). Employees of the Sponsor and its affiliates and subsidiaries; their advertising, promotion, and fulfillment agencies; and members of the immediate family or household of each of the above are not eligible to participate.
4. **HOW TO ENTER.** To enter, Entrant must follow the on-screen instructions on the designated post on Buffalo Bills' Facebook page (facebook.com/buffalobills), Twitter (twitter.com/buffalobills) or Instagram (instagram.com/buffalobills) during the "Sweepstakes Period" stated in Rule No. 2, and create a social media post to share on your account as directed and include the hashtag **#50YardFinish**.
