

**Sweepstakes Official Rules**  
**NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.**

Purchase does not increase chance of winning.

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Participation constitutes your (Entrant's) full and unconditional agreement to and acceptance of these Official Rules. The information in Rule No. 2 outlines the specifics for this Sweepstakes.
2. **Name of Sweepstakes:** Bills Pride Month Shirt Giveaway  
**Sweepstakes Period:** Begins 12:01am on June 17, 2020 and ends 11:59pm on June 30, 2020.  
**Drawing Dates:** On or about July 1, 2020  
**Prize Description:** Unisex T-Shirt featuring a Buffalo Bills pride logo.  
**Quantity and Value of Prizes to be Given Away:** Five (5) winners, one prize each; Value approximately \$18 per shirt  
**Sponsor(s):** Buffalo Bills, LLC, One Bills Drive, Orchard Park, NY 14127 (the "Bills")
3. Open to legal residents of the United States residing in New York State 18 years or older at time of entry (each eligible person to enter is an "Entrant"). Employees of the Sponsor and its affiliates and subsidiaries; their advertising, promotion, and fulfillment agencies; and members of the immediate family or household of each of the above are not eligible to participate.
4. **HOW TO ENTER.** To enter, Entrant must follow the on-screen instructions on the designated post on (a) Buffalo Bills' Twitter page (twitter.com/buffalobills) to retweet the designated sweepstakes tweet on Twitter or (b) Buffalo Bills' Instagram account (instagram.com/buffalobills) to comment on the Bills' designated sweepstakes post on Instagram while also tagging a friend in the comments, during the "Sweepstakes Period" stated in Rule No. 2. Entrant must abide by Instagram, Twitter, or Facebook Rules, depending upon their chosen method of entry, and Entrants must ensure that their relevant social media account's privacy settings are set to allow Buffalo Bills' respective social media accounts to view the entry and communicate with the Entrant.
