

## OFFICIAL RULES AND REGULATIONS

### CINCINNATI BENGALS x Bud Light Authentic Custom Jersey Sweepstakes

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**

The Sponsor of the Sweepstakes is Anheuser-Busch, LLC (the "Sponsor"), a Missouri limited liability company, with its principal place of business located at One Busch Place (202-7), St Louis, MO 63118 and the Administrator is the Cincinnati Bengals (the "Administrator"), an Ohio company, with its principal place of business located at One Paul Brown Stadium, Cincinnati, OH 45202.

1. **ELIGIBILITY; DURATION:** The Cincinnati Bengals x Bud Light Authentic Custom Jersey Sweepstakes (the "Sweepstakes") is open to legal residents of the of Ohio, Indiana and Kentucky who are at least 21 years old at the time of entry. Void where prohibited.

The Sweepstakes begins Tuesday, November 17, 2020 at 12:00 a.m. Eastern Time and ends Tuesday, December 1, 2020 at 5:00 p.m. Eastern Time ("Sweepstakes Entry Period"). Administrator is the official time keeper of this Sweepstakes. The Sweepstakes is governed by these Official Rules and Regulations and is subject to all applicable federal, state, and local laws.

2. **EXCLUSIONS TO ELIGIBILITY:** Employees, officers, directors, agents, and representatives of the Cincinnati Bengals and Anheuser-Busch, LLC and their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, advertising and promotion agencies, prize providers and their immediate family members and/or those living in the same household of each are not eligible. All federal, state and local laws and regulations apply.

3. **HOW TO ENTER:** During the Sweepstakes Entry Period, Entrants may enter the Sweepstakes by entering via the Official Bengals App sweepstakes form. To participate without downloading the Bengals Mobile App, an eligible entrant may hand-write his/her complete name (no initials), valid e-mail address, telephone number, their home ZIP code, jersey size, jersey color and custom jersey name to appear on back of the jersey on a 3½"x5" card ("Mail-In Entry") and mail it with sufficient postage to: Bengals x Bud Light Sweepstakes- A1-MeS; One Paul Brown Stadium, Cincinnati, OH 45202. All Mail-In Entries must be postmarked no later than November 30, 2020 and received on or before December 10, 2020. By entering, entrants are granting permission for their image and likeness to be used on Bengals.com and for other publicity and promotional purposes in conjunction with the Sweepstakes. Neither Sponsor, Administrator, nor their respective officers, directors, shareholders, employees, and agents are responsible for incorrect or inaccurate transcription of entry information. Entry materials that have been tampered with or altered are void. Sponsor and the Administrator reserve the right, in their discretion, to cancel, modify, or suspend the sweepstakes should technical or other occurrences beyond the control of the organization compromise the administration, security, or proper play of the Sweepstakes.

Limit one (1) entry per household/per email address.

By entering all Entrants agree to be bound by the terms and conditions of these Official Rules and Regulations.

4. **WINNERS/PRIZES:** Ten (10) Grand Prize winners will be randomly chosen on December 7, 2020 to receive an authentic custom jersey. Approximate Prize Value is \$350. The prize is non-transferable and awarded "as is" with no warranty or guarantee, either express or implied by Administrator or Sponsor.

Winner will be notified by email after the close of the Sweepstakes. Prize will be sent to winner through mail after custom order is submitted and completed, typically 4-6 weeks. Odds of winning depend upon the number of eligible entries received. If the Administrator is unable to reach a potential Winner via email within 48 hours after a potential Winner is selected or if any message is not returned within 24 hours, or if a potential Winner declines a Prize for any reason, then that potential winner will be disqualified and an alternate potential Prize Winner may be selected at random from the remaining eligible entries at Administrator's's discretion.

As a condition to eligibility to claim any Prize, potential Winner may be required in Administrator's sole discretion to execute an affidavit of eligibility and any further liability waivers or other documents required by Administrator. Entrants further agree to not knowingly damage or cause interruption of the Sweepstakes and/or prevent others from using the Sweepstakes. All decisions of the Cincinnati Bengals shall be final and Entrants waive any right to challenge any decisions made by the Cincinnati Bengals.
