OFFICIAL RULES

The RAIDERS HOLIDAY SWEEPSTAKES PRESENTED BY BOSE ("Sweepstakes") is sponsored by Raiders Football Club, LLC ("Sponsor"), and shall be administered by Sponsor or its designee ("Administrator").

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins at or about 10:00 AM Pacific Time ("PT") on December 8, 2020 and ends at 11:59:59 PM PT on December 20, 2020 ("Sweepstakes Period"). The Sweepstakes entry period ("Entry Period") will begin and end on the dates and times set forth below.

If the Sweepstakes has multiple Entry Periods, non-winning entries will carry forward to subsequent Entry Periods. The Administrator's computer is the Sweepstakes official clock.

- 2. ELIGIBILITY:** This Sweepstakes is offered only to legal residents of the United States who are at least eighteen (18) years old at the time of entry. Employees, directors, officers, and agents of Sponsor, Administrator, Bose Corporation, any other Raiders Entities, CAA Brand Consulting, the NFL Entities (defined as the National Football League ("NFL"), its member professional football clubs, NFL Ventures, Inc., NFL Ventures, L.P., NFL Properties LLC, NFL Enterprises LLC, NFL Productions LLC, NFL International LLC) and Promosis, Inc. (collectively, the "Sweepstakes Entities"), and each of their respective parent companies, divisions, dealers, affiliates, subsidiaries, advertising and promotional agencies and suppliers involved in the Sweepstakes, as well as the members of each of their immediate families (spouse, parents, children, siblings, and in-laws) and persons residing in the same household as such individuals are not eligible to enter or win. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

- 3. HOW TO ENTER THE SWEEPSTAKES:** Internet access and a valid e-mail address are required to participate. The information requested on the registration form may include without

limitation: entrant's first and last name (initials are not permitted), valid e-mail address, complete mailing address (P.O. Boxes are not permitted), date of birth, telephone number and affirmation that he/she has read and agrees to be bound by these Official Rules. Upon completion and submission of the registration form, the entrant will receive one (1) entry into the Sweepstakes.

4. **Entry Limit:** Each entrant is limited to receiving one (1) entry during the Sweepstakes. If more than one (1) entry is received from the same person, telephone number and/or e-mail address, only the first entry received may be considered valid.
5. **RANDOM DRAWING:** On or about each of the Random Drawing Dates set forth in the chart in Section 1, the Administrator will randomly select one (1) winner from all eligible entries received during the Sweepstakes Period ("Random Drawing"). Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.
6. **PRIZES, APPROXIMATE RETAIL VALUE ("ARV") AND ODDS OF WINNING:**
 - A. **Prize (1 total):** The one (1) grand prize includes: two (2) pairs of Bose Sport Earbuds (collectively, the "Prize"). Fulfillment of the Prize shall be managed or otherwise coordinated by Sponsor.
 - B. **Total ARV:** The total ARV of the Prize is \$360.
 - C. **Odds of Winning:** The odds of winning a Prize depend on the total number of eligible entries received during the applicable Entry Period.
 - D. **General:** To the extent the fulfillment of any Prize involves the distribution of any pre-paid cards, the use of any such pre-paid card shall be subject to the terms and conditions set forth thereon which shall govern the use of such pre-paid card. Potential winners will be notified by telephone or e-mail after the Random Drawing with instructions on how to claim a Prize. Raiders Football Club, LLC, LV Stadium Events Company, LLC, The Oakland Raiders, a California limited partnership, the Las Vegas Stadium Authority and each of their respective parent companies, subsidiaries, affiliates, divisions, suppliers, distributors, advertising/promotion agencies, and each such company's officers, directors, employees, representatives and agents (collectively, the "Raiders Entities") and the Sweepstakes Entities shall not be held responsible for any delays in awarding a Prize for any reason. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for any Prize won. A winner is not entitled to any difference between the ARV and the actual value of the Prize at the time the Prize is awarded. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. Each Prize will only be awarded to a verified winner.

INDEMNITY AND LIMITATION OF LIABILITY:** By entering the Sweepstakes or accepting any prize, all Entrants expressly agree to indemnify, defend, and hold harmless, and do hereby forever waive, release, discharge, and covenant not to sue the Raiders Entities, the Sweepstakes Entities, and/or any of their past and present partners, limited partners, owners, affiliates, members, managers, entity owners (and the current and former officers, directors, shareholders, partners, members, limited partners, managers, affiliates, assigns and employees of any owners or entity owners), employees, agents, attorneys, advertising, public relations, promotional, fulfillment and marketing agencies, website providers, directors, officers, shareholders, contractors, successors, assigns and insurers (collectively "Released Parties"), for and from any and all claims, debts, liabilities, demands, obligations, costs, fees, expenses, actions and causes of action whatsoever, of every nature, character and description (collectively, "Claims"), known and unknown, including, but not limited to, all those arising out of or in any way related to the Sweepstakes; these Official Rules (including the legality of these Official Rules or any portion hereof); Entrant's entry and/or eligibility in the Sweepstakes; the negligence of Raiders or any Raiders Related Party; any Prize (including without limitation the receipt, non-receipt, acceptance, rejection, possession, misuse or use of any Prize and any travel related to any prize); any purchase of tickets; any participation in the Sweepstakes; and any presence at any Sweepstakes-related or Prize-related venue (including without limitation any stadium or on the field or sideline thereof). The Released Parties are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a Prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. (each a “Force Majeure” event or occurrence), Sponsor reserves the right, at its sole and absolute discretion, to abbreviate, cancel, terminate, modify or suspend the Sweepstakes and/or proceed with the Sweepstakes, including the selection of winners in a manner it deems fair and reasonable, including the selection of winners from among eligible entries received prior to such cancellation, termination, modification or suspension without any further obligation provided a sufficient number of eligible entries are received. If Sponsor, in its discretion, elects to alter this Sweepstakes as a result of a Force Majeure event, a notice will be posted at the Website.

- 8. DISPUTES:** THESE OFFICIAL RULES SHALL BE CONSTRUED AND INTERPRETED ACCORDING TO THE LAWS OF THE STATE OF NEVADA WITHOUT REGARD TO CHOICE OF LAW PRINCIPLES. AS A CONDITION OF PARTICIPATING IN THIS SWEEPSTAKES, EACH ENTRANT AGREES THAT ANY AND ALL DISPUTES WHICH CANNOT BE RESOLVED BETWEEN THE PARTIES, AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THIS SWEEPSTAKES, SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION, EXCLUSIVELY BEFORE A COURT LOCATED IN CLARK COUNTY, NEVADA HAVING JURISDICTION. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS’ FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
- 9. PRIVACY POLICY:** Any personally identifiable information collected during an entrant's participation in the Sweepstakes will be collected by Sponsor or its designee and used by Sponsor, its affiliates, designees, agents and marketers for purposes of the proper administration and fulfillment of the Sweepstakes as described in these Official Rules and otherwise in accordance with Sponsor’s privacy policy at <https://www.raiders.com/footer/privacy-policy>.
- 10. PUBLICITY RIGHTS:** By participating in the Sweepstakes and/or accepting a Prize, each entrant hereby grants to Sponsor, the Raiders Entities, Bose Corporation, Promosis Inc. and their designee(s) a non-exclusive, royalty-free worldwide, perpetual right and license to use his/her name, biographical information, photos and likeness, voice recording, video images and all related footage, and statements for Sweepstakes, trade, commercial, advertising and publicity purposes, at any time or times, in all media now known or hereafter discovered worldwide including but not limited to television (including live television), radio, Internet, without notice, review or approval and without additional compensation except where prohibited by law.
