

**2020 FAN APPRECIATION MONTH CONTEST
PRESENTED BY VERIZON
OFFICIAL RULES**

1. **NO PURCHASE NECESSARY:** Void where prohibited. Subject to applicable federal, state and local laws.
2. **ELIGIBILITY:** Contest is open only to legal residents of the United States who are 18 years of age or older. Employees of Houston NFL Holdings, L.P. (the “Texans”), the National Football League (the “NFL”), Verizon, and each of their respective subsidiaries, affiliates and advertising/promotional agencies, and the immediate families and household members of each, are not eligible.
