

Contest Official Rules

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Participation constitutes your (Entrant's) full and unconditional agreement to and acceptance of these Official Rules. The information in Rule No. 2 outlines the specifics for this Contest.

Name of Contest: 2021 Draft Inner Circle Contest – Frontline Healthcare Workers
Contest Period: Begins 12:01am on April 9, 2021 and ends 11:59pm on April 13, 2021
Selection Date: On or about April 16, 2021
Prize Description: Two-night hotel accommodation in Cleveland, OH (Thursday 4/29 & Friday 4/30); opportunity to attend Day 1 and Day 2 of the 2021 Draft in the Buffalo Bills Inner Circle; Buffalo Bills gift pack of assorted team merchandise.
Quantity and Value of Prizes to be Given Away: Six Winners (each winner may be accompanied by one guest); Approximate total retail value of each Prize is \$1,000
Sponsor(s): Buffalo Bills, LLC, One Bills Drive, Orchard Park, NY 14127 (the "Bills")
3. **ELIBILITY.** Open to legal residents of one of the eight counties of Western New York (Erie, Allegany, Cattaraugus, Chautauqua, Genesee, Niagara, Orleans, and Wyoming counties in New York State) who (i) are 21 years or older at time of entry, (ii) are currently employed as a Frontline Healthcare Worker, as defined below, and (iii) will be fully vaccinated with one of the vaccines that have received emergency use authorization by the FDA for SARS-CoV-2 (the virus that leads to the illness known as COVID-19) by April 15, 2021 (each eligible person to enter is an "Entrant"). For purposes of this Contest, a "Frontline Healthcare Worker" means an individual currently employed in a hospital, medical center, long term care facility, or urgent care facility with a patient-facing role or duties. Employees of the Sponsor and its affiliates and subsidiaries; their advertising, promotion, and fulfillment agencies; and members of the immediate family or household of each of the above are not eligible to participate.
4. **HOW TO ENTER.** To enter, Entrant must complete the online entry form located at <http://marketing.psentertainment.com/draft-sweepstakes>, which includes writing a response (limit 300 words) to the question "*Why would you like to represent the team in Cleveland during the 2021 Draft?*", during the "Contest Period" stated in Rule No. 2. Limit one entry per person; multiple entries will not increase chances of winning and may result in Entrant's entry being filtered out. Enter using only a valid email account held by Entrant. All entries must be received by the Contest Period deadline stated in Rule No. 2. In the event of a dispute about entries submitted by multiple individuals using the same email account, entry will be deemed to have been submitted by the authorized holder of the email account used to enter the Contest at the actual time of entry. Entries generated by script, macro, robotic, programmed, or any other automated means are prohibited and will be disqualified. Entries containing offensive, obscene, derogatory, lewd, or other inappropriate content, as determined by the Bills in its sole discretion, are prohibited and will be disqualified.
