

OFFICIAL RULES AND REGULATIONS

CINCINNATI BENGALS x FIFTH THIRD MOMENTUM MEET

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

1. **ELIGIBILITY; DURATION:** The Cincinnati Bengals x Fifth Third Momentum Meet (the "Sweepstakes") is open to legal residents of the continental United States of America who are at least 18 years old at the time of entry, excluding residents of Florida and New York. Void where prohibited.

Administrator is the official time keeper of this Sweepstakes. The Sweepstakes is governed by these Official Rules and Regulations and is subject to all applicable federal, state, and local laws.
