

**2021 Chicago Bears – Week 2 United Club Gameday Sweepstakes**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.  
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. HOW TO ENTER:** The 2021 Chicago Bears – Week 2 United Club Gameday Sweepstakes (the “Sweepstakes”) starts September 19, 2021 at 10:00AM Central Time (“CT”) and closes at the completion of the first half of the day’s game (“Entry Period”). To enter the Sweepstakes, visit <https://www.chicagobears.com/game-day/united-club-affle> and complete the entry form by providing your first and last name, date of birth, email address, street address, zip code, and phone number (“Entry Form”). Limit one (1) entry per account during the Entry Period. Entrants that use multiple email addresses to enter the Sweepstakes will be disqualified.

**2. ELIGIBILITY:** The Sweepstakes is open to all legal residents of the United States ages 18 years and over as of September 19, 2021. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc.
