Entrant’s (“your,” “you,” or “entrant”) registration and participation in the Sweepstakes shall be governed by the terms and conditions contained herein (the “Official Rules”). ELIGIBILITY: The Sweepstakes is open only to permanent, legal residents physically residing in Florida, and excluding all U.S. territories and possessions and all overseas military installations.
