

**Panthers Moore Love Sweepstakes**  
**Presented by Bud Light**

**Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

**1) Eligibility:** The Panthers Moore Love Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of North Carolina and South Carolina, who, prior to the date of entry are twenty-one (21) years of age or older (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of Panthers Stadium, LLC, Panthers Football, LLC, the National Football League, its member professional football clubs, NFL Ventures, L.P., Anheuser-Busch, LLC, and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. **3) How to Enter:** During each Entry Period, @Panthers will tweet a promotional tweet inclusive of hashtag #MooreLoveSweepstakes. To receive one (1) entry into the applicable Entry Period, you must retweet the applicable tweet ("Retweet").

Your Retweet on Twitter must be public (not protected), include all Hashtags in the original tweet and conform to Twitter's (280) character limitation and Twitter Terms of Service and Twitter Rules available at [www.twitter.com](http://www.twitter.com) (hereafter, each, an "Entry"). Limit one (1) Entry per person/per Entry Period/Twitter account for a maximum limit of eight (8) Entries.
