Indianapolis Colts Season Ticket Bonus 1122 – PROMOTION OFFICIAL RULES Monday, November 22, 2021 – Sunday, December 26, 2021

- 1. The Indianapolis Colts Season Ticket Bonus 1122 promotion (the "Promotion") will take place between 12:00AM Eastern time on Monday, November 22, 2021, and 11:59PM Eastern time on Sunday, December 26, 2021 (the "Promotion Period").
- 2. As used herein, "Caesars" means American Wagering Inc, dba Caesars Sportsbook. Promotion is sponsored and administered by Caesars.
- 3. To be eligible for this Promotion, all patrons must be 21 or older, physically present in the State of Indiana, and have a Caesars Mobile or Online Account ("Caesars Account") ("Eligible Patron(s)").
- 4. Opening a Caesars Account is free.

5. Participation Criteria:

- i. Eligible Patrons with a Caesars Account registered prior to the Promotion Start Date ("Existing Participants").
- ii. Eligible Patrons that register with Caesars on or after the Promotion Start date ("New Participants").

6. Existing Participant Offer:

i. Existing Participants that are confirmed to have renewed or purchased their Season Ticket (non-club) with the Indianapolis Colts before the closing date of the Promotion Period will receive a Free Bet Bonus of \$100.00 to use on the Indianapolis Colts vs. Las Vegas Raiders NFL Game on January, 02, 2022 ("Free Bet").

7. New Participant Offer:

- i. New Participants that deposit at least \$50.00 ("Qualifying Deposit") and place a cash wager of at least \$50.00 ("Qualifying Wager") during the Promotion Period will receive a \$500.00 rebate applied to their Indianapolis Colts Season Ticket Account if they renew or purchase their Season Ticket (non-club) with the Indianapolis Colts.
- 8. If a Profit Boost Token is applied to a Qualifying Wager, that wager will not be eligible for the Promotion.
- 9. The usage of a previously accrued Free Bet in this Promotion is not a Qualifying Wager and will not be considered.
- 10. Qualifying Wagers that are settled via CashOut are not eligible for Free Bets.
- 11. Free Bets will be applied directly to a Participant's Caesars Account within four (4) days after the Promotion Period expires.
- 12. Free Bet redemption is subject to Caesars House Rules.
- 13. Eligible Patrons may opt out of this Promotion by contacting Caesars Customer Support.
- 14. Both New Participants' and Existing Participants' Caesars Accounts must be in good standing both at the time of entry and the time at which a Free Bet is awarded.
- 15. Participants may be notified by email, SMS, and/or phone when a Free Bet is added to their Caesars Account.
- 16. New Colts Season Ticket buyers must purchase two (2) or more seats to be eligible.

- 17. New Participants email with Caesars should match the email associated with Indianapolis Colts account.
- 18. Neither renewal of existing nor new purchase of Club Level or Suite Tickets will be eligible for this Promotion.
- 19. New Participants will have rebate issued within sixty (60) days of the Promotion closing date, rebate will be in the form of \$500.00 account credit to Indianapolis Colts account.
- 20. Indianapolis Colts account credit can only be redeemed for tickets, and cannot be exchanged for cash or any other goods or services.
- 21. Participation is void where prohibited or restricted by law.
- 22. This Promotion is subject to all applicable federal, state, and local laws and regulations, and all aspects of the Promotion are subject to the approval of appropriate regulatory authorities.
- 23. Unless prohibited by law, Participants consent and agree to allow Caesars the unconditional use of their name, voice, likeness and story for any promotions, advertising and announcements without compensation, consideration, notice, review, or approval.
- 24. Participants are responsible for payment of any and all taxes, licenses, registrations and other fees, as applicable.
- 25. Caesars reserves the right to make changes to or cancel the Promotion, for any reason, with or without notice, at any time. Other restrictions may apply.
- 26. Caesars reserves the right to change the rules of the Promotion due to unforeseen or extenuating circumstances.
- 27. All decisions regarding the interpretation of rules, eligibility, etc. for this Promotion lie solely with Caesars whose decisions are final.
- 28. Caesars may disqualify any Participant from receiving a Free Bet based upon fraud, dishonesty, violation of these rules or other misconduct whether or not related to this Promotion.

Neither Caesars nor the Indianapolis Colts, Inc. is responsible for lost, late, mutilated, or illegible entries or for electronic transmission errors or delays resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, hardware, software, or telephone failures of any kind, lost or unavailable connections, fraud, incomplete, garbled, or delayed computer transmissions, whether caused by Caesars, users, or by any of the equipment or programming associated with or utilized in the Promotion or by any technical or human error which may occur in the processing of submissions which may limit, restrict, or prevent a Participant's ability to participate in the Promotion.
- 31. If for any reason the Promotion is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes within or beyond the control of Caesars which corrupt or affect the

- administration, security, fairness, integrity, or proper conduct of this Promotion, Caesars reserves the right at its sole discretion to cancel, terminate, modify or suspend the Promotion.
- 32. Any attempt by any person to deliberately damage or undermine the legitimate operation of this Promotion may be a violation of criminal and civil laws and, should such an attempt be made, Caesars reserves the right to seek damages from any such person to the fullest extent of the law.
- 33. Records related to the Promotion will be retained for recordkeeping purposes in accordance with local legal and regulatory requirements.

- 35. Individuals who are excluded from online wagering, either through a government program or by their own request, are not eligible.

Any questions or disputes concerning the interpretation of these rules or situations not covered by these rules will be resolved by Caesars Management and that decision shall be final and binding on all Participants. If the Participant is not satisfied with the results of Caesars' decision, the Participant will have the option to seek resolution with the Indiana Gaming Commission.
- 40. This Promotion is being conducted in accordance with I.C. 4-38-1:11. Caesars Promotions will retain details of all Participants for sixty (60) days after the event in accordance with 68 IAC 1- 12.5.
- 41. Wagers placed at a Caesars retail location do not qualify for this Promotion.
