

2021 Chicago Bears Kids Club Guess the Score Sweepstakes

OFFICIAL RULES

1. HOW TO ENTER: The entry period for the 2021 Chicago Bears Kids Club Guess the Score Sweepstakes (the "Sweepstakes") starts December 16, 2021 at 9:00 AM central time ("CT") and ends on December 20, 2021 at 7:00 PM CT. You may enter one (1) or more of your children or legal wards in the Sweepstakes. Each child you enter into the Sweepstakes must be a member of the Chicago Bears Kids Club in order to be eligible to participate in the Sweepstakes.
