

2022 Chicago Bears Crib Club Family Portrait Sweepstakes
OFFICIAL RULES

1. HOW TO ENTER: The entry period for the 2022 Chicago Bears Crib Club Family Portrait Sweepstakes (the "Sweepstakes") starts March 14, 2022 at 9:00 AM central time ("CT") and ends on March 18, 2022 at 12:00 PM CT ("Entry Period"). You may enter one (1) or more of your children or legal wards in the Sweepstakes. Each child you enter into the Sweepstakes must be a member of the Chicago Bears Crib Club in order to be eligible to participate in the Sweepstakes. ELIGIBILITY: The Sweepstakes is open to all legal residents of the United States ages 18 years and over as of March 18, 2022, excluding residents of Rhode Island, and who has a child or legal ward who is a member of the Chicago Bears Crib Club.
