

CHICAGO BEARS 2022 FATHER'S DAY SWEEPSTAKES BROUGHT TO YOU BY MILLER LITE
OFFICIAL RULES

1. HOW TO ENTER: The 2022 Chicago Bears Father's Day Sweepstakes brought to you by Miller Lite (the "Sweepstakes") starts June 6, 2022 at 10:00AM Central Time ("CT") and ends on June 10, 2022 at 3:00PM CT ("Entry Period"). To enter the Sweepstakes, visit <https://www.chicagobears.com/sweepstakes/fathers-day-sweepstakes> and complete the entry form by providing your name, address, date of birth, email address, street address, zip code, and phone number ("Entry Form"). Limit one (1) entry per person during the Entry Period. Entrants that use multiple email addresses to enter the Sweepstakes will be disqualified.

2. ELIGIBILITY: The Sweepstakes is open to all legal residents of the United States ages 21 years and over as of June 6, 2022, excluding residents of Rhode Island. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc.
