

2022 Family Fest Jr. Staley & Jr. Squad Sweepstakes

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **HOW TO ENTER:** The entry period for the 2022 Family Fest Jr. Staley & Jr. Squad Sweepstakes (the "Sweepstakes") starts July 11, 2022 at 10 AM CT and ends on July 22, 2022 at 10:00 AM CT. You may enter one (1) or more of your children or legal wards in the Sweepstakes. To enter your child in the Sweepstakes, your child must be between the ages of 8 and 16. 2. **ELIGIBILITY:** The Sweepstakes is open to all legal residents of the United States, unless prohibited in the state, ages 18 years and over as of July 11, 2022 who has a child or legal ward who is between the ages of 8 and 16.
