

**NEW MEMBER MATCHUP SWEEPSTAKES  
FULL OFFICIAL RULES  
PROMOTION OPEN ONLY TO LEGAL RESIDENTS OF FLORIDA 18 YEARS AND OLDER  
AT TIME OF ENTRY**

**1. No Purchase Necessary:** NO ENTRY FEE, PAYMENT, OR PROOF OF PURCHASE IS NECESSARY TO ENTER OR WIN. The Promotion is void outside of the State of Florida. Must be 18 years or older at time of entry to enter.

**2. To Enter:** The promotion described herein, including the various drawings (each, a “Drawing”), shall be hereinafter referred to as the “Promotion.” During the Promotion Period (as defined below), two challenges will be distributed each week for four (4) weeks (for a total of eight (8) challenges) via email from Miami Dolphins, Ltd. (“MDL” or “Sponsor”). Entrants may complete each challenge and receive the associated point values. Each point is considered an individual entry to the Promotion. The more points you earn, the higher chance of receiving one of the prizes.

The total number of points earned by Entrant during the Promotion Period shall be equal to the number of entries that such Entrant will be awarded for the Drawings. Sponsor’s computer shall be the official timekeeping mechanism for the Promotion. Incomplete Promotion entries will not be accepted.
