

## **2022 EAGLES ONEPASS TRAINING CAMP SWEEPSTAKES – OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

### **1. Eligibility**

Sweepstakes is offered only in the United States to legal residents of Pennsylvania, New Jersey and Delaware who are eighteen (18) years of age or older as of the date of entry and attend a training camp practice at the NovaCare Complex during the Sweepstakes Period. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (“Eagles”) and any of their respective agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize. By entering, you agree to these Official Rules and the decisions of the Eagles (the judging organization), which are final and binding in all respects.

### **2. Sweepstakes Period**

Sweepstakes period begins on July 29, 2022 at the time the gates to training camp practice open and no earlier than 9:00 a.m. Eastern Time (“ET”) and ends at the end of training camp practice on July 29, 2022 and no later than 1 p.m. (the “Sweepstakes Period”).

### **3. Entry**

To enter, you must have downloaded the Official Eagles App and set up an Eagles OnePass account. If you do not have the Official Eagles App downloaded, visit the app store on your iOS phone or android phone and download the free Official Eagles App. To set up an Eagles OnePass account, within the Official Eagles App, log in to your profile. Within your profile, click on the Eagles OnePass icon, which will prompt you to add additional information, including your mobile phone number, zip code and date of birth, and then confirm that you agree to the Official Rules. During the Sweepstakes Period, there will be a QR code located at several locations near the practice fields. Entrants must scan the QR code one (1) time with the FanScan scanner located within Eagles OnePass. Upon scanning the QR code, an entrant, subject to the conditions below, will automatically be entered into the Sweepstakes. The Eagles’ computer shall be the official clock of the Sweepstakes. Entrants agree to be bound by the Official Rules.

**LIMIT ONE ENTRY PER PERSON DURING SWEEPSTAKES PERIOD (REGARDLESS OF WHETHER MORE THAN ONE PERSON USES THE SAME E-MAIL ACCOUNT).**

If more than one entry is submitted, only the first entry will be entered into the Sweepstakes and all other entries will be disregarded. In the event of a dispute as to any entry, the authorized account holder of the e-mail address used to enter will be deemed to be the entrant. The “authorized account holder” is the natural person assigned to the e-mail account. The potential winner(s) may be required to show proof of being the authorized account holder.

Automated entries (including but not limited to any entries submitted using any robot, script, macro or other automated service) are not permitted and will be disqualified.

malfunctions, failures, connections, availability or garbled or jumbled transmissions, or service provider/Internet/Web site/use net accessibility or availability, traffic congestion, or unauthorized human intervention. No mass entries or mechanically reproduced entries will be accepted. All entries become the exclusive property of the Eagles and will not be returned or acknowledged. Any attempts by an individual to access the Sweepstakes via a bot script or other brute-force attack will result in that IP address becoming ineligible. The Eagles will prosecute any fraudulent activities to the fullest extent of the law. The Eagles reserves the right to suspend or terminate this Sweepstakes without notice if, in the Eagles sole discretion, the Sweepstakes becomes infected or otherwise corrupted.

#### 4. Winner

There will be one (1) winner selected randomly by the Eagles from all eligible entries received during the Sweepstakes Period. The potential winner will be notified by the Eagles by e-mail or text message and instructed as to the specific location to obtain their prize. Return of any notification as undeliverable or if the potential winner does not claim prize by the end of the day's practice, the prize will be forfeited in its entirety and no alternate winners will be selected. Final designation as the winner depends on verification of eligibility as determined by Eagles. **Winner may not substitute or redeem prize for cash, but the Eagles reserves the right to substitute prize with a prize of equal or greater value should the advertised prize become unavailable for any reason.**

#### 5. Prize/Odds

In accordance with these Official Rules, one (1) winner will win one (1) autographed football (approximate retail value \$50). Player autograph to be determined in Eagles sole discretion.

**Odds of winning will be determined by the total number of eligible entries received during the Sweepstakes Period.** No assignment, transfer or substitution of prize is permitted except by the Eagles in the event of prize unavailability. Taxes on or connected with the prize and the reporting consequences thereof are the sole and exclusive responsibility of winner
