2022 EAGLES ONEPASS TRAINING CAMP SWEEPSTAKES - OFFICIAL RULES

Within your profile, click on the Eagles OnePass icon, which will prompt you to add additional information, including your mobile phone number, zip code and date of birth, and then confirm that you agree to the Official Rules. During the Sweepstakes Period, there will be a QR code located at several locations near the practice fields. Entrants must scan the QR code one (1) time with the FanScan scanner located within Eagles OnePass.
