

**2022 EAGLES ONEPASS TRAINING CAMP OPEN PRACTICE SWEEPSTAKES –  
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

**1. Eligibility**

Sweepstakes is offered only in the United States to legal residents of Pennsylvania, New Jersey and Delaware who are eighteen (18) years of age or older as of the date of entry and attend the Eagles Open Training Camp Practice scheduled to take place on August 7, 2022 at Lincoln Financial Field. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (“Eagles”) and any of their respective agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize. By entering, you agree to these Official Rules and the decisions of the Eagles (the judging organization), which are final and binding in all respects.

**2. Sweepstakes Period**

Sweepstakes period begins on August 7, 2022 at the time the Eagles Open Training Camp Practice (“Open Practice”) scheduled to take place at Lincoln Financial Field begins and no earlier than 5:00 p.m. Eastern Time (“ET”) and ends at 8:30 p.m. ET on August 7, 2022 (the “Sweepstakes Period”).

**3. Entry**

To enter, you must have downloaded the Official Eagles App and set up an Eagles OnePass account. If you do not have the Official Eagles App downloaded, visit the app store on your iOS phone or android phone and download the free Official Eagles App. To set up an Eagles OnePass account, within the Official Eagles App, log in to your profile. Within your profile, click on the Eagles OnePass icon, which will prompt you to add additional information, including your mobile phone number, zip code and date of birth and then confirm that you agree to the Official Rules. During the Sweepstakes Period, there will be four (4) QR codes at various locations in Pepsi Plaza and on the main concourse at Lincoln Financial Field. Entrants must scan at least two (2) QR codes with the FanScan scanner located within Eagles OnePass. Each unique QR code scanned within entrant’s Eagles OnePass will provide entrant with one (1) unique badge, which will appear within the Eagles OnePass account. Upon scanning at least two (2) different QR codes and attaining two (2) unique badges, an entrant, subject to the conditions below, will automatically be entered into the Sweepstakes. The Eagles’ computer shall be the official clock of the Sweepstakes. Entrants agree to be bound by the Official Rules.

**LIMIT ONE ENTRY PER PERSON DURING SWEEPSTAKES PERIOD (REGARDLESS OF WHETHER MORE THAN ONE PERSON USES THE SAME E-MAIL ACCOUNT).**

If more than one entry is submitted, only the first entry will be entered into the Sweepstakes and all other entries will be disregarded. In the event of a dispute as to any entry, the authorized account holder of the e-mail address used to enter will be deemed to be the entrant. The “authorized account holder” is the natural person assigned to the e-mail account. The potential winner(s) may be required to show proof of being the authorized account holder.

Any attempt by any person to submit more than the stated number of entries by using multiple/different accounts or any other methods will void that person’s entry and that person will

be disqualified. Automated entries (including but not limited to any entries submitted using any robot, script, macro or other automated service) are not permitted and will be disqualified.

No responsibility is assumed for lost, late, incomplete, stolen or misdirected entry; or for any computer, telephone, cable, network, satellite, electronic or Internet hardware or software malfunctions, failures, connections, availability or garbled or jumbled transmissions, or service provider/Internet/Web site/use net accessibility or availability, traffic congestion, or unauthorized human intervention. No mass entries or mechanically reproduced entries will be accepted. All entries become the exclusive property of the Eagles and will not be returned or acknowledged. Any attempts by an individual to access the Sweepstakes via a bot script or other brute-force attack will result in that IP address becoming ineligible. The Eagles will prosecute any fraudulent activities to the fullest extent of the law. The Eagles reserves the right to suspend or terminate this Sweepstakes without notice if, in the Eagles sole discretion, the Sweepstakes becomes infected or otherwise corrupted.

#### 4. **Winner**

There will be ten (10) winners selected randomly by the Eagles from all eligible entries received during the Sweepstakes Period between approximately 7:00 p.m. ET and 8:30 p.m. ET. The potential winners will be notified by the Eagles by e-mail or text message and must pick up their prize at the Kids Club Table on Pepsi Plaza. Return of any notification as undeliverable or if the potential winner does not claim prize by 11:59 p.m. ET or the end of the Open Practice, whichever is earlier, the prize will be forfeited in its entirety and no alternate winners will be selected. Final designation as the winner depends on verification of eligibility as determined by Eagles. **Winner may not substitute or redeem prize for cash, but the Eagles reserves the right to substitute prize with a prize of equal or greater value should the advertised prize become unavailable for any reason.**

#### 5. **Prize/Odds**

In accordance with these Official Rules, the following prizes will be awarded: ten (10) autographed footballs (approximate retail value \$250 each), total approximate retail value of all prizes \$2,500. Player autograph to be determined in Eagles sole discretion.

**Odds of winning will be determined by the total number of eligible entries received during the Sweepstakes Period.** No assignment, transfer or substitution of prize is permitted except by the Eagles in the event of prize unavailability. Taxes on or connected with the prize and the reporting consequences thereof are the sole and exclusive responsibility of winner
