

Carolina Panthers Champions Sweepstakes
Presented by WellCare

Abbreviated Rules:

Sweepstakes is open to legal residents of the U.S. who are 18 years of age or older to enter. Sweepstakes begins on 8/29/22 and ends 12/19/22. Void where prohibited. Visit www.panthers.com for Official Rules. Entrant need not be a WellCare customer to participate. Enrolling with WellCare will not increase your chances of winning.

1. **Sweepstake Period.** Sweepstakes begins on August 29, 2022 and ends on December 19, 2022 (hereafter “Promotion Period”) and will be divided into nine (9) entry periods (each, an “Entry Period”) as indicated in the chart below. All Entry Periods begin at 12:00:00 AM ET and end at 11:59:59 PM ET.

2. **Eligibility.** The Sweepstakes is open to legal permanent residents of North Carolina and South Carolina, who, prior to the date of entry are eighteen (18) years of age or older. You need not be a WellCare customer to be eligible. Enrolling with WellCare will not increase your chances of winning.

3. **How to Enter.** To enter the Sweepstakes, during any/all Entry Periods, visit <https://www.panthers.com> and complete and submit the registration form to receive one (1) entry into the Sweepstakes. All non-winning entries during each Entry Period will be rolled over and included in the subsequent Entry Period. **Limit of one (1) entry per person throughout the Promotion Period.** Entries received in excess of the stated limitation will be void. become the exclusive property of the Administrator and will not be acknowledged or returned. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Administrator's sole discretion and in accordance with these Official Rules) are void. 6. Prizes. On or about each Drawing Date listed above, one (1) potential winner will each receive four (4) lower level tickets to one (1) 2022 Carolina Panthers Home Game and one (1) replica of a Carolina Panthers Football Jersey. ARV of each prize: \$836; total value of all prizes: \$5,852.

Home Game to be determined by Administrator in its sole discretion. Location of seats subject to Administrator sole discretion. Parking, food and beverage at Home Game, transportation to Home Game, hotel/lodging accommodations (if necessary) and all other costs or expenses associated

selection of winner from among eligible entries received prior to such cancellation, termination, modification or suspension without any further obligation provided a sufficient number of eligible entries are received. Without limiting the foregoing, everything regarding this Sweepstakes, including the Prize, is provided “as is” without warranty of any kind, either express or implied, including but not limited to, the implied warranties of merchantability, fitness for a particular purpose or non-infringement.
