

**Harris Teeter Get Gameday Ready Sweepstakes**  
**Official Rules**  
**NO PURCHASE NECESSARY TO ENTER OR WIN.**

**1) Eligibility:** The Sweepstakes (hereafter, “Sweepstakes”) is open to legal permanent residents of North Carolina and South Carolina who, prior to the date of entry are eighteen (18) years of age or older (hereafter, “Eligible Entrants”). Employees, officers, directors, agents and representatives of Panthers Stadium, LLC, Panthers Football, LLC (hereafter, “Sponsor”), the National Football League, its member professional football clubs, NFL Ventures, L.P., Harris Teeter, LLC, UTZ Brands Inc., Tyson Foods, Inc., each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies, sponsors (hereafter collectively, “Released Parties”), and each such individual’s immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void outside of North Carolina, South Carolina, and where prohibited by law. All applicable federal, state & local laws apply.

**2) Promotion Period:** Sweepstakes starts at 11:00:00 am Eastern Time (“ET”) on September 1, 2022 and ends at 11:59:59 pm ET on January 3, 2023 (hereafter, “Promotion Period”) and will be divided into eighteen (18) entry periods (each, an “Entry Period”) as indicated in the chart below. All Entry Periods begin at 12:00:00 AM ET and end at 11:59:59 PM ET except for Entry Period 1, which begins at 11:00:00am Eastern Time (“ET”) on September 1, 2022.

**3) How to Enter:** There are two ways to enter. During any/all Entry Periods, visit <https://www.panthers.com/fans/get-game-day-ready> or

<https://www.harristeeter.com/panthers> and complete and submit the registration form to receive one (1) entry for a maximum of eighteen (18) entries throughout the Promotional Period. Non-winning entries in each Entry Period will not roll over and will not be included in any subsequent Entry Period. **Limit of one (1) entry per person per Entry Period will be accepted for a maximum of eighteen (18) entries throughout the Promotion Period. Entries received in excess of the stated limitation will be void.** All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor's sole discretion and in accordance with these Official Rules) are void. Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, inaccurate, destroyed or undelivered entries, entry information or for telephonic, human or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, emails or the announcement of a prize; or for any injury or damage to entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Sponsor reserves the right, in its sole discretion, to void any entries of entrants who Sponsor believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes or is in violation of these Official Rules.

**Entry by Mail.** In lieu of the on-line entry method, you may also enter simply by hand-printing your name, complete address (including city, state and zip code), day and evening phone numbers and age on a single 3" X 5" card (the "Mail-In Entry") and mailing it to: 2022 Harris Teeter/Carolina Panthers Get Game Day Ready Sweepstakes, Harris Teeter, Inc., P.O. Box 10100, Matthews, NC 28106. No purchase or ownership or use of a VIC Card is necessary to enter by mail. Customers are limited to one (1) Mail-In Entry per entry period, per household and only one Mail-In Entry per envelope. Only original hand printed Mail-In Entries are eligible. Mechanically reproduced Mail-In Entries will not be accepted. Each Mail-In Entry must be placed in a separate outer mailing envelope. Any Mail-In Entry received in excess of the one request per entry period and/or the one request per envelope will not be entered into the drawing. All Mail-In Entries must be postmarked by January 4, 2023 and received by noon on January 6, 2023 in order to be eligible. All Mail-In Entries become the exclusive property of Harris Teeter and will not necessarily be acknowledged or returned.

**4) Winner Selection:** On or about each Drawing Date listed above, one (1) potential First Prize winner will be randomly selected from among all entries received during each Entry Period; for a total of eighteen (18) potential First Prize winners during the Promotional Period. Two (2) Grand Prize winners will be randomly selected from all

entries throughout the Promotional Period on or about 1/18/2023. Odds of winning a prize depends upon the total number of eligible entries received throughout each Entry Period. Limit one (1) First Prize per person during the Promotional Period. Limit one (1) Grand Prize per person. By entering, entrants agree to be bound by these Official Rules and to the decisions of the Sponsor, which will be final and binding in all respects. The potential winners will be notified by telephone and/or email and may be required to execute and return a Prize Claim form, and/or any other required documentation required by Sponsor within two (2) days of the date of issuance of notification. Non-compliance with the foregoing, with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner.

ARV: \$500 each prize. Prizes are awarded "as is" without any warranty or guarantee, either express or implied by Sponsor. Terms and conditions apply to gift cards as determined by issuer. All prize details are at Sponsor's sole discretion. Costs and expenses associated with the acceptance and use of each prize not specified herein as being awarded, including, but not limited to, federal, state and local taxes (if any) are each winner's sole responsibility. ARV of all prizes awarded: \$9,000.

**Two (2) Grand Prizes:** Each Grand Prize winner and one guest will receive one (1) Away Game Trip Experience to a 2023 Regular Season Carolina Panthers away game. Away game experience consists of two (2) tickets to one (1) 2023 regular season Carolina Panthers away game; round trip, economy class airfare for two (2) from Charlotte, NC; one room double occupancy hotel accommodations for two (2) at Sponsor's sole discretion; and one (1) Visa Gift card of up to \$300 to cover ground transportation and meals. ARV: \$5,000 each prize. 2023 NFL Preseason, Playoffs and Superbowl not included with this prize; grand prize winner must choose away game at least 30 days after 2023 Carolina Panthers NFL game schedule has been release. Each Grand Prize winner and his/her travel guest must travel together on the same itinerary. Minors must be accompanied by his/her parent/legal guardian and such person must accompany the Grand Prize winner as the designated travel guest. ARV of all prizes awarded: \$10,000.

**6) Miscellaneous:** No transfer, assignment, cash redemption, or substitution of a prize is permitted except by Sponsor who reserves the right to substitute the prize (or applicable portion thereof) with one of comparable or greater value, at its sole discretion. Entrants agree, by entering, that 1) Sponsor and its designees may use (unless prohibited by law), entrant's name, city and state of residence, photograph and/or likeness for advertising, trade and/or any other purposes in any media now or hereafter known throughout the world in perpetuity, without further compensation, permission or notification, 2) Sponsor reserves the right to conduct a background check and entry in the Sweepstakes constitutes entrant's permission for Sponsor to conduct such background check, provided that, to the extent additional authorization is necessary under law, entrants shall authorize such check. Sponsor reserves the right (at its sole discretion) to disqualify any entrant based on the results of the background check or failure of the entrant to properly authorize such check, and 3) the Released Parties shall have no liability and will be held harmless by entrant for any claim, action, liability, loss, injury or damage to entrant or any other person or entity, including, without limitation, personal injury or death to entrant or any other person or damage to personal or real property, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of a prize or participation in this Sweepstakes. Sponsor reserves the right, in its sole discretion, to modify, suspend, and/or terminate this Sweepstakes (or portion thereof) for any reason, including should virus, bugs, non-authorized human intervention or other causes corrupt or impair the administration, security, fairness or proper play of the Sweepstakes and, in the case of termination, at its discretion, select the winner from among all eligible non-suspect entries received during the applicable Entry Period prior to the event that required such termination. **CAUTION:** Any attempt to deliberately damage the website or undermine the legitimate operation of this Sweepstakes is a violation of criminal and civil laws and should such an attempt be made, the Sponsor reserves the right to seek any and all remedies available from any such person(s) responsible for the attempt to the fullest extent permitted by law.

**7) Arbitration:** Except where prohibited by law, as a condition of participating in this Sweepstakes, entrant agrees that (1) any and all disputes and causes of action arising out of or connected with this Sweepstakes, or the prizes awarded, shall be resolved individually, without resort to any form of class or collective action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at a reasonable location within Mecklenburg County, North Carolina; (2) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than entrant's actual out-

of-pocket expenses (i.e., costs associated with participating in this Sweepstakes), and entrant further waives all rights to have damages multiplied or increased.

**8) Choice of Law:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the Mecklenburg County, North Carolina, USA.
