

# **Prowl the Den Sweepstakes**

## **Official Rules 2022**

### **NO PURCHASE NECESSARY TO ENTER OR WIN.**

1) Eligibility: The Prowl the Den Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of North Carolina and South Carolina who are eighteen (18) years of age or older as of November 5, 2022. Employees, officers, directors, agents and representatives of Allen Tate Company (hereafter, "Sponsor"), Panthers Stadium, LLC, Panthers Football, LLC, the National Football League, its member professional football clubs, NFL Ventures, L.P., and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies ("Panthers") (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. 2) Promotion Period: Sweepstakes starts 9:00:00 am Eastern Time ("ET") on September 6, 2022, and ends at 11:59:59 pm ET on October 27, 2022 (hereafter, "Promotion Period").

Entries must be received by 11:59:59 pm ET on October 27, 2022 to be eligible. Only one (1) entry per person will be accepted throughout the Promotion Period, regardless of the method of entry. Winners and guests will also attend a pre-tour tailgate party with games, food, and beverages.

One (1) Grand Prize will be awarded. Grand Prize winner will be randomly selected from 25 tour winners. Grand Prize is 4 suite tickets and 4 field passes to the November 27, 2022 Carolina Panthers vs. Denver game at Bank of America Stadium, Charlotte, NC, and 4 replica player Carolina Panthers jerseys subject to NFL, Panthers and Bank of America Stadium health and safety policies. (Approximate retail value of Grand Prize: \$ 1,315.00). The Grand Prize will be awarded on November 5, 2022. Odds of winning depend on the number of eligible entries received throughout the Promotion Period. Each eligible entry will have an equal chance of winning and must be present to win.

All prize details are at Sponsor's sole discretion. Prize is awarded "as is" without any warranty or guarantee, either express or implied by Sponsor.
