

SOCIOS MIAMI DOLPHINS SUITE GIVEAWAY SWEEPSTAKES OFFICIAL RULES (IG)

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Eligibility

The Sweepstakes is offered only to legal United States residents in the South Florida Region comprised of Miami-Dade, Broward, and Palm Beach counties, and who are at least eighteen (18) years of age or older at the time of entry (“Eligible Entrants”). Employees of Socios Services USA, Inc. (“Socios”) (“Sponsor”) or the Miami Dolphins, Ltd.
