

LOS ANGELES RAMS AVOCADOS FROM PERU SWEEPSTAKES

Official Sweepstakes Rules Updated as of September 21, 2022

NO PURCHASE NECESSARY. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE THE UNITED STATES, NEW YORK, FLORIDA AND WHERE PROHIBITED BY LAW. ENTRANT MUST BE 21 YEARS OF AGE OR OLDER AND LEGAL RESIDENT OF THE 50 UNITED STATES OR THE DISTRICT OF COLUMBIA AT THE TIME OF ENTRY. 1. ELIGIBILITY: Sweepstakes is open to legal residents of the United States, other than New York and Florida, who are 21 years of age or older at the time of entry. The following persons are not eligible to participate: The Los Angeles Rams, LLC (“Rams”), the Peruvian Avocado Commission, Geostrategic LLC, the NFL Entities (as defined below), each of their respective parent companies, affiliates, subsidiaries, distributors, dealers, sales representatives, web masters/suppliers, advertising and promotional agencies, anyone associated with the development, implementation or execution of this Sweepstakes, and members of the immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above. Participation constitutes entrant’s full and unconditional agreement to abide by and be bound by these Official Rules and Sponsors’ decisions, which are final and binding in all matters related to the Sweepstakes. SWEEPSTAKES PERIOD: This Sweepstakes will consist of one selection for three (3) prize winners: The Sweepstakes entry period begins on Sunday, September 18, 2022 at 12:01AM PT and ends on Monday, October 24, 2022 at 5:00 PM PT (the “Entry Period”). Rams’ computer server is the official time-keeping device for Sweepstakes. Winner Selection and Notification: There will be one (1) selection to award one (1) individual prize winner. The potential winner will be selected by the Rams from all eligible entries submitted in a selection taking place on or about Monday, October 24, 2022.

3. AGREEMENT TO OFFICIAL RULES: Participation constitutes entrant’s full and unconditional agreement to these Official Rules, that they are 18 years of age or older and agree to abide by Sponsor’s decisions, which are final and legally binding in all matters related to the Sweepstakes.

4. For an additional entry you may post from your Instagram account a photo using the hashtag “#RamsAvosFromPeru”. Any entrants who entered prior to Wednesday, September 21, 2022, at 5:00 p.m. PT will automatically be given an additional entry. They will not be eligible for any additional entry in excess of the two (2) entries received, by using the hashtag additional method of entry. Partial or incomplete/piecemeal submissions WILL NOT BE ACCEPTED as Sweepstakes entries and shall not be eligible for the any prize. **Limit two (2) entries per person, only one (1) entry by filling out the form and one (1) additional entry by posting from your Instagram account, regardless of entry method.** Entrants who entered prior to the modification of these rules shall automatically receive an additional entry, but in no event shall any entrant receive more than two (2) entries. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different accounts, identities, registrations and logins, or any other methods will void that entrant’s entries and that entrant may be disqualified. By submitting a Submission, Entrant agrees that the Submission is gratuitous and made without restriction, and will not place Sponsors under any obligation. Entrant agrees that Sponsors are free to disclose or otherwise disclose the ideas contained in the entry on a non-confidential basis to anyone or otherwise use the ideas without any additional compensation to entrant. Entrant acknowledges that, by acceptance of your Submission, Sponsors do not waive any rights to use similar or related ideas previously known to Sponsors, or developed by its employees, or obtained from sources other than entrant.

5. ODDS: Odds of winning depend upon the number of eligible entries received during the Sweepstakes Period.

Three (3) prize winners will be selected at random by the Rams on or about Monday, October 24, 2022; from among all eligible entries received. Potential winners will be notified by phone or through his/her email account. Potential winner may be required to complete, sign and return an Affidavit of Eligibility and Liability/ Publicity Release within a specified time period, or to respond to Sponsor's inquiries as to eligibility, as a condition of being awarded the Prize. If potential winner cannot be reached after reasonable efforts have been made (as determined by Sponsor), if Prize notification is returned as undeliverable, if a potential winner is determined by Sponsor to be ineligible, or if a potential winner cannot or does not comply with these Official Rules, such person will be disqualified and, at Sponsor's discretion, an alternate potential winner may be selected via random drawing from among the remaining eligible entries.

Sponsor shall have no liability if notification is lost, intercepted or not received for any reason. Sponsor is not responsible for any change in entrant's email account or other contact information subsequent to entering the Sweepstakes.

7. PRIZE DETAILS: The one (1) grand prize winner shall receive one (1) Los Angeles Rams and Avocados from Peru branded Hyundai Ioniq 5 vehicle. The grand prize has an approximate retail value (ARV) of Sixty Thousand Two Hundred Forty Five Dollars (\$60,245). The second place prize winner shall receive two (2) round trip flights from Los Angeles to Lima, Peru from American Airlines, and two (2) roundtrip flights from Lima, Peru to Cusco, Peru, two (2) night hotel stay in Lima, Peru in a Hilton Hotel, two (2) night hotel stay in Cusco, Peru in a Hilton Hotel, and a One Thousand Dollar (\$1,000) stipend to pay for two (2) trips to Machu Pichu from Cusco the dates and times of the travel shall be mutually agreed upon but must take place within 365 days from the date the winner receives verification that they are the second prize winner. The second-place prize has an approximate retail value (ARV) of Four Thousand Eight Hundred Forty Five Dollars (\$4,845). The one (1) third place prize winner shall receive two (2) game tickets, two (2) VIP tailgate tickets and one (1) parking pass for the Rams vs. Broncos game on Sunday, December 25, 2022 at SoFi Stadium,. The third-place prize has an approximate retail value (ARV) of eight-hundred-and-twenty dollars (\$820). Any costs or expenses not specified herein related to the acceptance and use of any prize are the sole responsibility of the prize winners including, but not limited to, costs or expenses for transportation for winners and winner's guest(s) to and from the game for winner and winner's guest(s) at the game or other travel expenses related to the Peruvian trip which are not specifically described herein. Winners are required to comply with all Rams and SoFi Stadium rules, regulations and requirements. No prize substitution (in whole or in part), cash redemption, sale or transfer of prize permitted by the winners, except at Sponsor's sole discretion. The Released Parties (as defined below) will not be responsible for weather conditions; acts of God; acts of terrorism; civil disturbances; local, state, or federal regulation, order, or policy; work stoppage; epidemic, pandemic, or any other issue concerning public health or safety; or any other event outside of their control that may cause the cancellation or postponement of, or the restriction on fans attending, any Rams Game. Game tickets awarded as prizes may not be resold, offered for resale, or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture and may invalidate the license granted by the Game ticket. Admission to SoFi Stadium is subject to all rules, requirements, and policies, including, without limitation, all security, fan conduct, and safety and health requirements and policies, put in place by the NFL and SoFi Stadium, including requirements relating to face masks and enhanced health screenings (which may include a requirement that ticket holders be tested for COVID-19 prior to or during the game or provide proof of full vaccination against COVID-19 prior to attending the game) as they may be updated from time to time. The Winner and Winner's guest

must also comply with all applicable laws, policies, orders, protocols, and guidelines issued by federal, state, and local authorities respecting COVID-19 and other communicable diseases, and attendance at the game is conditioned on such compliance. Receiving the prize is contingent upon compliance with these Official Rules and passing a background check to the Rams satisfaction in the Rams sole discretion. In the event that a potential winner is disqualified for any reason, Sponsor will award the Prize to an alternate potential winner from among all remaining eligible entries.

8. RELEASE OF LIABILITY AND PUBLICITY CONSENT: By participating in the Sweepstakes, entrants (and their parent(s)/legal guardian(s) if entrants are minors who are expressly prohibited from entering) release, indemnify and hold harmless the Sponsor, the Peruvian Avocado Commission, the NFL Entities, and each of their respective parent companies, affiliates, subsidiaries, officers, directors, partners, equity holders, agents, employees, and all others associated with the development and execution of this Sweepstakes (collectively, the “Released Parties”) from and against any and all claims, damages or liabilities with respect to, or in any way arising from or relating to such entrant's participation or attempt to participate in the Sweepstakes, the ability or inability to upload or download any information in connection to the Sweepstakes and/or the acceptance or use (included related travel if any) of the Prize (if applicable), including without limitation liability for personal injury, damages, death, monetary loss, defamation or violation of privacy rights.
