

## 2022 Chicago Bears Kids Club Movie Night Sweepstakes

### OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.  
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. HOW TO ENTER:** The entry period for the 2022 Chicago Bears Kids Club Movie Night Sweepstakes (the "Sweepstakes") starts October 12, 2022 at 10:00 AM central time ("CT") and ends on October 18, 2022 at 12:00 PM CT ("Entry Period"). You may enter one (1) or more of your children or legal wards in the Sweepstakes during the Entry Period. Each child you enter into the Sweepstakes must be a member of the Chicago Bears Kids Club in order to be eligible to participate in the Sweepstakes. **2. ELIGIBILITY:** The Sweepstakes is open to all legal residents of the United States, excluding residents of Florida, New York, and Rhode Island, ages 18 years and over as of October 12, 2022, who has a child or legal ward who is a member of the Chicago Bears Kids Club. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc.
