**VEGAS VACATION PRESENTED BY MATTRESS FIRM
SWEEPSTAKES**

OFFICIAL RULES

NO PURCHASE REQUIRED TO ENTER OR WIN.

1. **ELIGIBILITY:** The San Francisco 49ers Vegas Vacation presented by Mattress Firm Sweepstakes (the “Sweepstakes”) is open only to legal residents of the State of California who are eighteen (18) years of age or older. Employees of the National Football League, its member clubs, including, without limitation, the San Francisco 49ers, NFL Ventures, Inc., NFL Ventures, L.P., NFL Properties LLC, and each of their respective parents, subsidiaries, affiliates, shareholders, officers, directors, agents, representatives and employees (collectively, the “NFL Entities”), Mattress Firm, or other companies associated with the promotion of the Sweepstakes, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to federal, state, and local laws and regulations and is void in Puerto Rico and where prohibited.
2. **SPONSOR:** The Sweepstakes are sponsored by Forty Niners Football Company LLC and Mattress Firm, Inc. (together with their affiliates, the “Sponsor” or “Mattress Firm”).
3. **AGREEMENT TO OFFICIAL RULES:** Participation in the Sweepstakes constitutes entrant’s full and unconditional agreement to and acceptance of these official rules (“Official Rules”) and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
4. **ENTRY PERIOD:** The Sweepstakes run from November 30, 2022 at 9:00 am PT until December 14, 2022 at 11:59 pm PT (the “Entry Period”). Entries that are submitted prior to or after the Entry Period will be disqualified.
5. **HOW TO ENTER:**

In order to enter the Sweepstakes and be eligible for the corresponding prize, entrants must complete the online form located at <https://www.49ers.com/vegasvacation> correctly during the Entry Period. The winner will be selected at random from the pool of eligible entrants who follow the instructions and complete the online form correctly. There is a limit of one (1) entry per person. Entrants submitting multiple entries will be disqualified and not entered into the drawing. **ENTRANTS MUST BE 18 YEARS OF AGE IN ORDER TO BE ELIGIBLE.**
6. **SPONSOR OWNERSHIP OF ENTRIES.** All entries and materials submitted to Sponsor in connection with the Sweepstakes (collectively, “Entry Materials”), along with all copyright, trademark and other proprietary rights associated therewith, become the property of Sponsor upon submission, and Entry Materials will not be returned to any entrant.

7. **DRAWING AND ODDS OF WINNING:** As soon as practicable following the Entry Period, the Sponsor will select one (1) potential winner in a random drawing of all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via email. If a potential winner does not respond within twenty four (24) hours of first contact or is not eligible or does not wish to accept the prize (as described below), the Sponsor may disqualify that potential winner and select an alternate potential winner in his/her place at random from the remaining eligible entries received.
8. **REQUIREMENTS OF POTENTIAL WINNERS:** The potential winner may be required to complete and return an affidavit of eligibility and liability/publicity release (the "Affidavit/Release") where permitted by law within forty-eight (48) hours of being notified. If the potential winner fails to sign and return the Affidavit/Release within the required time period, he/she will be disqualified and an alternate entrant may be selected in his/her place in a random drawing of all entries received.
9. **PRIZE:** One (1) winner will be awarded the following prizes (collectively, the "Prize"):
 - First Class or equivalent round-trip airfare for winner and one guest to Las Vegas, NV from December 30, 2022 to January 1, 2023;
 - Two (2) nights at a hotel;
 - Room drop of two (2) Mattress Firm Sleep Kits;
 - Two (2) tickets to the Predators vs. Golden Knights game at 12:00 pm on Saturday, December 31, 2022;
 - Two (2) tickets to a show on Saturday night, December 31, 2022;
 - Two (2) tickets to the San Francisco 49ers vs. Las Vegas Raiders game (the "Game") on Sunday, January 1, 2022;
 - Two (2) pre-game sideline access passes to be used prior to the Game;
 - One (1) VISA gift card of \$500 to be used for food expenses;
 - Private car service to and from the Game;
 - One (1) autographed merchandise item; and
 - One (1) gift card of \$500 to shop49ers.com store.

The approximate retail value ("ARV") of the Prize is Seven Thousand Dollars (\$7,000)

All travel arrangements will be made through Sponsor. Unless otherwise determined by Sponsor, all travelers must travel on the same itinerary within the continental United States. Exact travel dates will be December 30, 2022 – January 1, 2023. If winner is unable to travel on the dates specified by Sponsor then the winner forfeits the prize and an alternate winner will be selected by Sponsor, time permitting, from among all remaining eligible entries received for the Sweepstakes. Transportation type may include air, rail and/or other ground method as determined by Sponsor in its sole discretion. No compensation or substitution will be provided for the difference in values of any transportation method. Actual value shall be based on fluctuations of actual ground, air or rail costs and the distance between departure city and destination.

For the Game: The game date and time is subject to change. Transportation will be provided to the game. Sponsor makes no guarantee as to the location of the seats for the game and exact seats will be determined by Sponsor in its sole discretion. Sponsor is not responsible for lost or mutilated tickets, and none will be replaced. Winner and guest must comply with all stadium rules and regulations, including without limitation, all health and safety protocols, and ticket terms and conditions at all times. Failure to do so may result in forfeiture of the prize. The terms and conditions of the tickets awarded will govern in the event a legal game, exhibition, or event, as defined by the team, is not played due to weather, an act of God, an act of terrorism, civil disturbance, or any other reason. Sponsor reserves the right to remove or to deny entry to any winner and/or guest who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the game. Sponsor will not be responsible for acts of God, acts of terrorism, civil disturbances, work stoppage or any other natural disaster outside their control that may cause the cancellation of the game. In the event the game is cancelled or delayed, Sponsor will work with the winner to provide tickets to an alternate game, however, travel will not be awarded. Resale of game tickets is strictly prohibited. For the avoidance of doubt, unused tickets cannot be refunded, exchanged or applied towards tickets for any subsequent game or for cash.

The odds of being selected depend on the number of entries received. All prize details will be determined by the Sponsor in its sole discretion. Prizes are not transferable or refundable and must be accepted as awarded by winner. No cash or other substitution may be made, except by the Sponsor, who reserves the right to substitute a prize (or component thereof) with another prize (or component thereof) of equal or greater value if the prize is not available for any reason as determined by the Sponsor in its sole discretion. Winner is responsible for all costs and expenses associated with prize acceptance and use not listed above as being provided, including but not limited to meals, incidentals, ground transportation, souvenirs, taxes, fees, surcharges. Prizes will be reported as income to the winner and the winner will be responsible for all federal, state and local taxes associated with the receipt of any prize.

10. **PRIVACY AND PUBLICITY:** By entering the Sweepstakes, each entrant consents to having their information used as described in these Official Rules. All information submitted by entrants in the Sweepstakes will be treated according to Sponsor's Privacy Policy, available at <http://www.49ers.com/about-us/privacy-policy.html> and CCPA Notice, available at <https://www.49ers.com/about-us/ccpa-notice>. With respect to Mattress Firm, any information provided shall be by Mattress Firm in accordance with Mattress Firm's Privacy Policy, which can be viewed at <https://www.mattressfirm.com/privacy-policy.html>. Additionally, except where prohibited, participation in the Sweepstakes constitutes an entrant's consent to the Sponsor's use of his/her name, likeness, voice, opinions, biographical information, contents of the entry form, and state of residence for promotional purposes in any future promotional activity related to this Sweepstakes without further payment or consideration.

11. **GENERAL CONDITIONS:** In the event that the operation, security, or administration of the Sweepstakes is impaired in any way for any reason, including, but not limited to fraud, virus, or other technical problem, the Sponsor may, in its sole discretion, either (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of these Official Rules or (b) award the prizes at random from among the eligible entries received up to the time of the impairment. The Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

12. **RELEASE AND LIMITATIONS OF LIABILITY:** By participating in the Sweepstakes, each entrant (hereinafter, "Entrant") agrees to release and hold harmless the Sponsor, the NFL Entities, Mattress Firm, and each of their respective parent, officers, directors, employees, and agents (the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to: (a) any error that may prevent an entrant from submitting an entry; (b) unauthorized human intervention in the Sweepstakes; (c) printing or typographical errors in materials associated with the Sweepstakes; (d) lost or late entries; (e) errors in the administration of the Sweepstakes or the processing of entries; (f) alleged or actual violations of rights of publicity or privacy, defamation or portrayal in a false light, whether intentional or unintentional; (g) telephone, electronic, hardware, software, network, Internet, or other computer- or communications-related malfunctions or failures; or (h) injury, death, or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt of any prize, whether under a theory of contract, tort (including negligence), warranty or other theory. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the Released Parties be liable for attorney's fees. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

IF ENTRANT IS A CALIFORNIA RESIDENT, ENTRANT WAIVES CALIFORNIA CIVIL CODE SECTION 1542, WHICH STATES: "A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY" (OR ANY EQUIVALENT STATUTORY PROVISION WITH A SIMILAR IMPORT OR INTENT). IF ENTRANT IS A RESIDENT OF A STATE OTHER THAN CALIFORNIA, ENTRANT EXPLICITLY WAIVES THE TERMS AND

PROTECTIONS OF ANY STATUTE OF HIS/HER STATE THAT HAS A SIMILAR IMPORT OR INTENT.

13. **DISPUTES: EXCEPT WHERE PROHIBITED,** any controversy, claim or dispute arising out of these Sweepstakes (including without limitation any controversy, claim or dispute arising from Entrant's dealings with third-party sponsors for products and/or services promoted in, awarded in, linked or otherwise associated with the Sweepstakes (each such third-party sponsor, a "Third Party Sponsor")) (collectively, "Claims") shall be resolved by final and binding arbitration. Such arbitration shall take place in Santa Clara County, California, and shall be administered by a single arbitrator pursuant to the JAMS Comprehensive Arbitration Rules and Procedures. The Sweepstakes shall be governed under the laws of the State of California, without regarding to conflicts of law principles to the contrary. In order to keep costs down for both Sponsor and Entrant, hearings may, at Sponsor's request, be conducted telephonically or entirely upon submissions. Entrant expressly consents to the exercise of jurisdiction and venue by the state and federal courts located in Santa Clara County, California. In addition to the above, Entrant waives the right to bring any Claim as a class action, consolidated, multi-district or collective action, or private attorney general action. Entrant also agrees not to participate in any class action, consolidated, multi-district or collective action, or private attorney general action regarding any Claim. If Sponsor prevails in any arbitration or proceeding hereunder, Sponsor shall be entitled to recover, in addition to all other available legal and equitable relief, its legal costs, including attorneys' fees. Entrant acknowledges and agrees that each Third Party Sponsor will be deemed a "Sponsor" and a third-party beneficiary of the terms and conditions set forth in this paragraph.

15. **SEVERABILITY:** These Official Rules for the Sweepstakes are severable, and if any portion is determined invalid or unenforceable by a body of competent jurisdiction, the remaining portions will remain valid, enforceable and in effect to the fullest extent consistent with applicable law.
