

## 2023 Chicago Bears Kids Club & Baby Bears Winter Gear Sweepstakes

### OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.  
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. HOW TO ENTER:** The entry period for the 2023 Chicago Bears Kids Club & Baby Bears Winter Gear Sweepstakes (the "Sweepstakes") starts January 23, 2023 at 10:00 AM central time ("CT") and ends on January 27, 2023 at 12:00 PM CT ("Entry Period"). You may enter one (1) or more of your children or legal wards in the Sweepstakes during the Entry Period. To enter your child in the Sweepstakes, your child must be a member of the Chicago Bears Kids Club ("Kids Club") or Chicago Bears Baby Bears ("Baby Bears"). **2. ELIGIBILITY:** The Sweepstakes is open to all legal residents of the United States ages 18 years and over as of January 23, 2023, who has a child or legal ward who is a member of the Kids Club and/or Baby Bears. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc. Sponsor will contact the parent or legal guardian who entered the Prize Winner in the Sweepstakes via email or telephone. Odds of winning depend upon the number of eligible entries received.

**5.
