

2023 Chicago Bears Baby Bears Family Portrait Sweepstakes
OFFICIAL RULES

- 1. HOW TO ENTER:** The entry period for the 2023 Chicago Bears Baby Bears Family Portrait Sweepstakes (the "Sweepstakes") starts March 6, 2023 at 10:00 AM central time ("CT") and ends on March 10, 2023 at 12:00 PM CT ("Entry Period"). You may enter one (1) or more of your children or legal wards in the Sweepstakes. Each child you enter into the Sweepstakes must be a member of the Chicago Bears Baby Bears in order to be eligible to participate in the Sweepstakes.
