

**2023 CHICAGO BEARS DRAFT INSIDER SWEEPSTAKES BROUGHT TO YOU BY MILLER  
LITE OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.  
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. HOW TO ENTER:** The 2023 Chicago Bears Draft Insider Sweepstakes brought to you by Miller Lite (the "Sweepstakes") starts March 13, 2023 at 10:00AM Central Time ("CT") and ends on March 17, 2023 at 11:59 PM CT ("Entry Period"). To enter the Sweepstakes, visit <https://www.chicagobears.com/sweepstakes/draft-insider> and complete the entry form by providing your name, address, date of birth, email address, and phone number ("CB.com Entry Form"). Limit one (1) entry per person during the Entry Period. Entrants that use multiple email addresses to enter the Sweepstakes will be disqualified.

**2. ELIGIBILITY:** The Sweepstakes is open to all legal residents of the contiguous United States ages 21 years and over as of March 13, 2023, excluding residents of Rhode Island. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc. ("Sponsor" or "Chicago Bears"), **Molson Coors Beverage Company USA LLC ("Miller Lite")**, the National Football League "NFL", and their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, advertising and promotion agencies, and their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, half-sister) and/or those living in the same household of each are not eligible. All federal, state and local laws and regulations apply. Void where prohibited by law.

**3. PRIZE:** One (1) prize winner (the "Prize Winner") will receive the following prizes (collectively, the "Prize"):

- Two (2) tickets to the Inner Circle to represent the Chicago Bears at the NFL Draft in Kansas City, MO for Thursday, April 27 (Round 1) and Friday, April 28 (Rounds 2 & 3);
- Two (2) round-trip airline tickets to Kansas City, MO;
- Three-night hotel accommodations for Wednesday, April 26 through Friday, April 28 (one room for two); and
- One (1) Bears autographed item;

Approximate retail value of the Prize is \$2,392. Sponsor reserves the right to substitute any part of the Prize with another of equal value should any unforeseen circumstances occur. All state, federal, and local taxes or other expenses not specified herein are the sole responsibility of the Prize Winner, including, without limitation, any costs or expenses associated with travel to and from Union Station. No substitutions or cash redemption will be made except in Sponsor's sole discretion. The Prize is non-transferable.

The Prize Winner must agree and be available to participate in media interviews as determined by Sponsor and the National Football League. In Sponsor or the NFL's discretion, the Prize Winner may be required to sign a participation agreement and/or additional publicity release prior to participating in the NFL Draft Inner Circle Experience. During the NFL Draft Inner Circle Experience, the Prize Winner agrees to act in compliance with all of Sponsor's and the NFL's rules and standards, including but not limited to (1) displaying appropriate credentials; (2) refraining from unruly, loud and/or disruptive behavior; and (3) avoiding showing up in an intoxicated state or otherwise displaying signs of alcohol consumption or use of any controlled

The unavailability of the Prize Winner to be reached after a reasonable (as determined solely by Sponsor) effort has been made may constitute forfeiture of being a Prize Winner, at Sponsor's sole discretion, and a new Winner may be selected from the remaining eligible entries. ADDITIONAL DISCLAIMERS:** If the Sweepstakes is not capable of running as planned for any reason, including, without limitation, because of a printing error, human error, unauthorized intervention, fraud, technical failure or other cause which corrupt or threaten to corrupt or adversely affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to cancel, modify or suspend the Sweepstakes, including awarding the Prize from among eligible entries received prior to the date of the cancellation, modification or suspension. All entrants, as a condition of entry, agree to abide by and be bound by these Official Rules and the decisions of Sponsor. Failure to comply with these Official Rules may result in disqualification from this Sweepstakes. Sponsor reserves the right to permanently disqualify any person it believes has violated these Official Rules. Entrants further agree to not knowingly damage or cause interruption of the Sweepstakes and/or prevent others from using the Sweepstakes.
