

**2023 CHICAGO BEARS FAN IN FOCUS SWEEPSTAKES
IN ASSOCIATION WITH THE INVISALIGN® BRAND
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. HOW TO ENTER: The 2023 Chicago Bears Fan in Focus Sweepstakes in association with the Invisalign® brand (the “Sweepstakes”) starts April 3, 2023 at 10:00AM Central Time (“CT”) and ends on April 7, 2023 at 11:59PM CT (“Entry Period”). To enter the Sweepstakes, visit <https://www.chicagobears.com/sweepstakes/fan-in-focus> and complete the entry form by providing your name, address, date of birth, email address, and phone number (“CB.com Entry Form”). Limit one (1) entry per person during the Entry Period. Entrants that use multiple email addresses to enter the Sweepstakes will be disqualified.

2. ELIGIBILITY: The Sweepstakes is open to all legal residents of the contiguous United States ages 18 years and over as of April 3, 2023, except residents of Rhode Island. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc. (“Sponsor” or “Chicago Bears”), the National Football League, Align Technology, Inc. (“Align”) and their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies, and their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, half-sister) and/or those living in the same household of each are not eligible. All federal, state and local laws and regulations apply. Void where prohibited by law.

3. PRIZE: One (1) prize winner (the “Prize Winner”) will receive the following prizes (collectively, the “Prize”):

- (a) Come to “Halas Hall” on a date, to be mutually determined by Prize Winner and Sponsor, and have photographs taken on the same production set that the Chicago Bears players use for approximately forty-five (45) minutes (“Photo Shoot”);
- (b) Select digital assets of the Photo Shoot;
- (c) One (1) personalized Chicago Bears jersey; and,
- (d) One (1) autographed Chicago Bears item.

Approximate retail value of the Prize is \$750. Sponsor reserves the right to substitute any part of the Prize with another of equal value should any unforeseen circumstances occur. All state, federal, and local taxes or other expenses not specified herein are the sole responsibility of the Prize Winner, including, without limitation, any costs or expenses associated with travel to and from Halas Hall. No substitutions or cash redemption will be made except in Sponsor’s sole discretion. The Prize is non-transferable.

Prize Winner must act in compliance with all of Sponsor’s rules for the Photo Shoot. This means that during the time that the Prize Winner is participating in the Photo Shoot they must (1) follow all of the instructions provided by the designated Sponsor’s representatives; (2) remain in the designated areas for the Photo Shoot; (3) refrain from taking photographs or videos at Halas Hall; (4) dress in appropriate attire (preferable Chicago Bears jersey or gear) and refrain from wearing the gear of any NFL team except for the Chicago Bears; and (5) avoid showing up in an intoxicated state or otherwise displaying signs of alcohol consumption or use of any controlled dangerous substances. Failure to comply with any of the above may result in disqualification of the Prize Winner at the sole discretion of Sponsor.

4. SELECTION OF WINNER: The Prize Winners will be selected in a random drawing held on or about April 10, 2023 from among all eligible entries received. The Prize Winners will be notified by email or telephone on or about April 10, 2023. Odds of winning depend upon the number of eligible entries received.

The unavailability of any Prize Winners to be reached after a reasonable (as determined solely by Sponsor) effort has been made may constitute forfeiture of being a Prize Winner, at Sponsor's sole discretion, and a new Winner may be selected from the remaining eligible entries. In addition, if the Prize Winner is selected and subsequently becomes unavailable to receive the Prize and/or attend the Game as set forth in Paragraph 3 above, he/she will be disqualified at Sponsor's sole discretion and a new Prize Winner may be selected from the remaining eligible entries. The Prize Winner must agree and be available to participate in media interviews as determined by Sponsor.
