OFFICIAL RULES & HOW TO ENTER (the "Official Rules")

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** Contest is open only to legal residents of the United States residing in Maryland, Virginia, and District of Columbia. Open to individuals eighteen (18) years of age and older. Void where prohibited. Eligibility determinations will be made by Sponsor (as defined herein) in its sole discretion and will be final and binding. Employees, agents, and representatives (and their immediate families (parent, child, spouse, or sibling, and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related) of (1) Pro-Football, Inc., d/b/a Washington Commanders ("PFI" or "Sponsor"), (2) the NFL Entities (defined below), (3) SeatGeek, Inc. ("SeatGeek"), and their respective parents, affiliates, subsidiaries, and advertising and promotion agencies are not eligible to enter or win. The NFL Entities shall be defined as the National Football League ("NFL"), its member professional football clubs, NFL Ventures, Inc., NFL Ventures, L.P., NFL Properties LLC, NFL Enterprises LLC, and each of their respective subsidiaries, affiliates, shareholders, officers, directors, agents, representatives, and employees. By participating, entrants agree to be bound by these Official Rules and the decisions of the judge and/or PFI, which are binding and final on matters relating to this Contest. This Contest is subject to all applicable federal, state, and local laws. There will be one (1) winner ("Winner") among those participants who correctly enter the Contest under the guidelines stated herein. Sponsor has the right, in its sole discretion, to modify these Official Rules (including without limitation by adjusting any of the dates and/or timeframes stipulated in these Official Rules) and to cancel, modify or suspend this Contest at any time in its discretion.

**TIMING:** Contest begins on April 11, 2023 at 12:00 PM Eastern Standard Time ("EST") and ends on April 30, 2023 at 11:59 PM EST (the "Contest Period"). PFI must receive all entries by the end of the Contest Period.

ANY ENTRY RECEIVED AFTER THE CLOSE OF THE ENTRY PERIOD WILL NOT BE ACCEPTED.

**HOW TO ENTER:** There is one (1) way for participants to enter during the Contest Period.

- **Online:** Participants must click the link here [https://tradablebits.com/tb\\_app/484400](https://tradablebits.com/tb_app/484400) and submit their prediction for the Washington Commanders' 2023-24 NFL season schedule (the "Schedule"). For the avoidance of doubt, the Schedule includes both the pre-season and regular season.

Limit to one (1) entry per person. For the avoidance of doubt, a participant will have one (1) attempt to predict the Schedule for this Contest.

An entry is not received until the above task is completed by the participant. All entries must be received by the end of the Contest Period to be eligible.

**The following applies to all entries, regardless of entry method:** By submitting an entry, the entrant warrants and represents that he/she and any persons appearing or who are identifiable in the entry consent to the submission and use of the entry in the Contest and to its use as otherwise set forth herein. Sponsor may, in its sole discretion, alter or remove any entry. Sponsor reserves the right to waive the entry requirements in its reasonable discretion.

By submitting your entry, you agree that your entry conforms to these Official Rules and that PFI, in its sole discretion, may disqualify your entry for any reason, including if it determines, in its sole discretion, that your entry fails to conform to these Official Rules in any way. Each entrant agrees that Released Parties (as defined below) are not responsible for any unauthorized use of entries by third parties. Released parties do not guarantee the posting of any entry. Entries must be received during the Contest Period. Proof of sent entry or entry receipt (such as a copy of a “thank you” message) does not constitute proof of actual receipt of entry by Sponsor for purposes of this Contest. Limit one (1) prize per person, regardless of the number of entries during the Contest Period. Multiple entries received from any person or email address or household during the Contest Period will be void. Entries generated by script, macro or other automated or mechanical means and entries by any means which subvert the entry process are void. Entries not legitimately submitted in accordance with these Official Rules are void. Entries that are late, incomplete, copied, misdirected, mutilated, illegitimate, postage-due, inaccurate, illegible, lost, damaged, or generated by automated means are void. All required information on the entry platform must be provided, or entry will be void.

**CONDITIONS OF ENTRY:** As a condition of entry into the Contest, which you hereby acknowledge is good and valuable consideration, you hereby grant to PFI and its respective designees, affiliates and licensees permission and license to reproduce, distribute, prepare derivative works of, edit, copy, display publicly, and otherwise use the pictures, video, information, or other content you submit as part of this Contest. As a further condition of entry into the Contest, which you hereby acknowledge is good and valuable consideration, you hereby grant to PFI and/or Sponsor and each of their respective affiliates and licensee’s permission and license to use each entrant’s name, voice, performance, photograph/video and/or likeness. You acknowledge that each of the foregoing permissions and licenses shall be perpetual and irrevocable, and the rights granted shall include any use (whether now known or hereinafter contemplated), via any and all media (whether now known or hereinafter devised), worldwide, for any purpose (including without limitation advertising, promotional, trade, or other purposes), without any further permission or additional consideration required.

**JUDGING CRITERIA:** At the end of the Contest Period, representatives of PFI will judge all of the eligible entries submitted during the Contest Period. The judges will identify the participant who correctly predicted the Schedule as the potential Winner. PFI shall consider the Winner as a potential Winner pending verification of the potential Winner’s eligibility and compliance with these Official Rules. In the event of any ties for the Grand Prize (as defined below), one Winner will be chosen in a random drawing conducted by PFI. In the event that no participant correctly predicts the Schedule, a Consolation Prize (as defined below) will be given to the participant who: (1) correctly predicted the most games on the Schedule; and (2) correctly predicted the regular season home opener of the Schedule. In the event of any ties for the Consolation Prize, one Winner will be chosen in a random drawing conducted by PFI. Sponsor reserves the right to not award all prizes if, in its sole discretion, it does not receive a sufficient number of eligible and qualified entries.

**WINNER NOTIFICATION:** The potential Winner will be notified by phone, e-mail, or any other means in PFI's sole discretion on or about May 2, 2023 at 12:00 PM EST. Except where prohibited by law, entry constitutes permission for Sponsor, its designees, affiliates, and licensees to use the potential Winner's name, hometown, and likeness for online posting, and/or any advertising and publicity without additional compensation. The potential Winner will be required to execute and return an affidavit of eligibility, a liability release, intellectual property assignment and release, and a publicity release within forty-eight (48) hours of receipt. If (i) such documents are not returned within the specified time period, (ii) a prize or prize notification is rejected, faulty or returned as undeliverable, (iii) PFI is unable to contact the potential Winner within forty-eight (48) hours of notification, (iv) the potential Winner is not in compliance with these Official Rules, or (v) the potential Winner does not claim the prize by May 4, 2023 at 12:00 PM EST, then the prize will be forfeited and, at PFI's discretion an alternate Winner will be selected for this Contest on May 5, 2023 at approximately 12:00 PM EST. \* SeatGeek acknowledges that it is solely responsible to pay the cash prize and any associated costs related to the cash prize. For the avoidance of doubt, Sponsor shall not be responsible for (i) paying the cash prize or any associated costs related to the cash prize, or (ii) insuring the cash prize.

\*\* Specific away game, away game tickets, flight information, and hotel accommodations shall be determined by Sponsor in its sole discretion and subject to availability.

\*\*\* Specific season ticket seating location shall be determined by Sponsor in its sole discretion and subject to availability.

Released Parties are also not responsible for any incorrect or inaccurate information whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest. PFI reserves the right at its sole discretion to suspend, modify, or terminate the Contest should any portion of the Contest be, in PFI's sole opinion, compromised by virus, worms, bugs, non-authorized human intervention or other causes which, in the sole opinion of the PFI, corrupt or impair the administration, security, fairness, or proper play, or submission of entries, or for any other reason determined by PFI in its sole discretion and, if terminated, at its discretion, select the potential Winner in accordance with the above-reference judging procedure from all eligible, non-suspect entries received for the applicable drawing prior to action taken or as otherwise deemed fair and appropriate by PFI. PFI is not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's e-mail account to receive e-mail messages. PFI is not responsible, and may disqualify an entrant, if his or her e-mail address, telephone, or other contact information does not work or if it is changed without entrant giving prior written notice to PFI. PFI's failure to or decision not to enforce any provision in these Official Rules will not constitute a waiver of that or any other provision. In the event there is an alleged or actual ambiguity, discrepancy, or inconsistency between disclosures or other statements contained in any Contest-related materials and/or these Official Rules (including any alleged discrepancy or

inconsistency in these Official Rules), it will be resolved in PFI's sole discretion. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. If PFI determines at any time in its sole discretion that the Winner or potential Winner is disqualified, ineligible, or in violation of these Official Rules, PFI reserves the right in its sole discretion to select an alternate potential Winner, even if the disqualified potential Winner's name may have been shown or announced publicly. If any person supplies false information, obtains entries by fraudulent means, or is otherwise determined to be in violation of these Official Rules in an attempt to obtain any prize, PFI may disqualify that person and seek damages from him or her and that person may be prosecuted to the full extent of the law. **Entrants, by participating, agree that Pro-Football, Inc., WFI Stadium Inc., Washington Football, Inc., WFI Group, Inc., Washington Football Park, Inc., and Washington Commanders Charitable Foundation, Inc. **DISPUTES:** Any controversy, dispute, or claim regarding the performance or interpretation of this Contest shall be resolved by binding arbitration, at the request of either party, in accordance with JAMS Streamlined Arbitration Rules and Procedures, with such arbitration to be conducted in Loudoun County, Virginia. The parties hereby waive their right to a jury trial. Except where prohibited, as a condition of participating in this Contest, each entrant agrees that any and all disputes that cannot be resolved between the entrant and any Released Party, claims and causes of action arising out of or connected with this Contest, or the prize awarded, or the determination of the prize must be resolved individually, without resort to any form of class action. Further, in any such dispute, under no circumstances will an entrant be permitted or entitled to obtain awards for, and hereby waives all rights to claim punitive, incidental, or consequential damages, or any other damages, including attorneys' fees, other than entrant's actual out-of-pocket expenses (if any), not to exceed two hundred fifty dollars (\$250), and entrant further waives all rights to have damages multiplied or increased.
