

2023 Chicago Bears Draft Party Thursday Sweepstakes
OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

1. HOW TO ENTER: Attend the “Chicago Bears Draft Party” at the Soldier Field on Thursday, April 27, 2023 from 6:00 PM central time (“CT”) to 10:00 PM CT (“Event”) and fill out an entry form (“Entry Form”). Limit one entry per person.

2. ELIGIBILITY: The Sweepstakes is open to all legal residents of the United States ages 18 years and over as of April 27, 2023, excluding residents of Florida, New York, and Rhode Island. You do not need to be present at Soldier Field at the time of the drawing and announcement of a Prize in order to be eligible to win that Prize. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc. (“Sponsor”), Sponsor’s Prize suppliers, and their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, advertising and promotion agencies, and their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, half-sister) and/or those living in the same household of each are not eligible. Failure to comply with these Official Rules may result in disqualification from this Sweepstakes. Sponsor reserves the right to permanently disqualify any person it believes has violated these Official Rules.
