## 2023 Chicago Bears Baby Bear Crawl Sweepstakes OFFICIAL RULES

## NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. HOW TO ENTER: The entry period for the 2023 Chicago Bears Baby Bear Crawl Sweepstakes (the "Sweepstakes") starts July 17, 2023 at 10:00 AM central time ("CT") and ends on July 21, 2023 at 12:00 PM CT ("Entry Period"). You may enter one (1) or more of your children or legal wards in the Sweepstakes during the Entry Period.
