2023 Chicago Bears Kids Club Jr. Reporter Contest

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. HOW TO ENTER: The entry period for the 2023 Chicago Bears Kids Club Jr. Reporter Contest (the "Contest") starts Monday, July 24, 2023 at 10:00 AM Central Time ("CT") and ends on Friday, July 28, 2023 at 12:00 PM CT ("Entry Period"). You may enter one (1) or more of your children or legal wards in the Contest during the Entry Period. To enter your child in the Contest, your child must be a member of the Chicago Bears Kids Club. You can sign your child up for a free Chicago Bears Kids Club membership at https://www.chicagobears.com/kidsclub. Membership is limited to children between the ages of 3 and 12. To enter the Contest, complete the entry form available at: https://www.chicagobears.com/sweepstakes/kid-zone/kids-club-junior-reporter ("Entry Form") and upload a one (1) minute and thirty (30) second or shorter video of your child explaining why he or she wants to be a junior Chicago Bears reporter ("Video").
- **2. ELIGIBILITY:** The Contest is open to all legal residents of the United States ages 18 years and over as of July 24, 2023, who has a child or legal ward who is a member of the Chicago Bears Kids Club. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc. The unavailability of the Prize Winner's parent or legal guardian to be reached after a reasonable (as determined solely by Sponsor) effort has been made may constitute forfeiture of the prize, at Sponsor's sole discretion, and a new Prize Winner may be selected by Sponsor.
