

**CITY FURNITURE “BEST SEATS IN THE STADIUM” PROMOTION
FULL OFFICAL RULES**

NO ENTRY FEE, PAYMENT, OR PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW OR REGULATION.

BY COMPLETING AND SUBMITTING AN ENTRY FORM FOR THE SWEEPSTAKES, YOU UNCONDITIONALLY ACCEPT AND AGREE TO THESE OFFICIAL RULES, WHICH FORM A CONTRACT. This Sweepstakes is sponsored by Miami Dolphins, Ltd. (“**Miami Dolphins**” or “**Sponsor**”), having a corporate address of 347 Don Shula Drive, Miami Gardens, FL 33056. By participating in the Sweepstakes, each Entrant agrees to comply with and abide by these Official Rules (the “**Official Rules**”) and the decisions of Sponsor.

1. ELIGIBILITY: The City Furniture “Best Seats in the Stadium” Promotion (the “**Sweepstakes**”) is open to permanent, legal residents physically residing in Florida who are eighteen (18) years of age or older at the time of entry (the “**Entrant**”). The Sweepstakes begins on July 21, 2023, at 12:00am Eastern Time (“**ET**”) and ends on January 5, 2024, at 11:59pm ET (“**Sweepstakes Period**”). To enter, Entrant must:

1. Navigate to the City Furniture “Best Seats in the Stadium” Sweepstakes page at <https://www.miamidolphins.com/forms/city-furniture-best-seats>.
2. Enter your full name (first and last), mobile phone number, email address, and zip code.

3. Check the checkboxes for acknowledgement of these terms and use of the Entrant’s information supplied in the Official Entry Form for marketing purposes.
4. Click “Submit.”

After you have completed the above steps, you will automatically be entered into the Sweepstakes. By entering, you agree to receive emails from Sponsor and agree that your registration and any other information collected in connection with the Sweepstakes may be used by Sponsor.

The winner of each of the ten (10) Sweepstakes Drawings will receive one (1) Prize that consists of: two (2) Miami Dolphins tickets in the 72 Club section at Hard Rock Stadium for one (1) Sponsor-designated game during the 2023 NFL season (the "**Dolphins Home Game**"). The total approximate retail value ("ARV") of each Prize is Three Thousand Five Hundred Dollars (\$3,500.00). The total ARV of the ten (10) Prizes is Thirty Five Thousand Dollars (\$35,000.00).

NFL game tickets awarded as prizes may not be resold, offered for resale, or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the license granted by the game ticket.
