

2023 Family Fest Jr. Monster Squad Sweepstakes

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **HOW TO ENTER:** The entry period for the 2023 Family Fest Jr. Monster Squad Sweepstakes (the "Sweepstakes") starts July 24, 2023 at 10 AM CT and ends on July 28, 2023 at 12:00 PM CT. You may enter one (1) or more of your children or legal wards in the Sweepstakes. To enter your child in the Sweepstakes, your child must be between the ages of eight (8) and sixteen (16). You can enter a child in the Sweepstakes by completing the entry form available at <https://www.chicagobears.com/sweepstakes/kid-zone/ff-youth>.

2. **ELIGIBILITY:** The Sweepstakes is open to all legal residents of the United States, ages 18 years and over as of July 24, 2023 who has a child or legal ward who is between the ages of eight (8) and sixteen (16). 3. **PRIZE:** Five (5) children that are entered into the Sweepstakes by their parents or legal guardians will be selected as Jr. Monster Squad Members "Prize Winners" (each a "Prize Winner"). Each Prize Winner will win the following prizes (collectively referred to as "Prize"):

- i. Four (4) tickets to 2023 Meijer Chicago Bears Family Fest on August 6, 2023. At least one (1) parent or legal guardian must be in attendance with the Prize Winner and give their permission for the child to participate;

- iii. (1) monster squad t-shirt.

Approximate retail value of the Prize is \$400. Sponsor reserves the right to substitute the Prize with another of equal value should any unforeseen circumstances occur. Sponsor will contact the parent or legal guardian who entered each Prize Winner in the Sweepstakes via email or telephone. Odds of winning depend upon the number of eligible entries received.
