2023 Chicago Bears Youth DJ Contest

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. HOW TO ENTER: The entry period for the 2023 Chicago Bears Youth DJ Contest (the "Contest") starts Monday, July 24, 2023 at 10:00 AM Central Time ("CT") and ends on Friday, July 28, 2023 at 12:00 PM CT ("Entry Period"). To enter the Contest you must be between the ages of thirteen (13) years old and sixteen (16) years old during the Entry Period and (i) complete the entry form available at:

("Entry Form") and (ii) upload a one (1) minute and thirty (:30) second or shorter video of your disc-jockey ("DJ") set and a short bio ("Video"). CONSENT OF PARENT OR LEGAL GUARDIAN: Each Entrant, that is a minor in his/her state of residence, must follow the instructions to provide his/her parent's or legal guardian's complete name, valid email address and phone number. Limit one entry per person ("Entrant").

- 2. ELIGIBILITY: The Contest is open to all legal residents of the United States between the ages of 13 years old and 16 years old as of July 24, 2023. If you are a minor in your state of residence, you must have the permission and consent of your parent/legal guardian to participate and claim Prize (as described below) in this Contest. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc. ("Sponsor" or "Chicago Bears"), and their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributers, advertising and promotion agencies, and their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, half-sister) and/or those living in the same household of each are not eligible. Sponsor will notify the parent or legal guardian of the Prize Winner using the email address or phone number provided by the parent or legal guardian on the Entry Form. The unavailability of the Prize Winner's parent or legal guardian to be reached after a reasonable (as determined solely by Sponsor) effort has been made may constitute forfeiture of the prize, at Sponsor's sole discretion, and a new Prize Winner may be selected by Sponsor.
