

**Club-Level Terrace Ticket Sweepstakes**  
**Presented by Ticketmaster**  
**Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

**1) Eligibility:** The Club-Level Terrace Ticket Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of North Carolina or South Carolina, (hereafter, "Eligible Entrants" or "Entrants"). Employees, officers, directors, agents, and representatives of Panthers Stadium, LLC, Panthers Football, LLC ("Carolina Panthers"), the National Football League, its member professional football clubs, NFL Ventures, L.P., Ticketmaster LLC ("Ticketmaster"), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void outside of North Carolina, South Carolina, and where prohibited by law. All applicable federal, state & local laws apply.

**2) Promotion Period:** Sweepstakes starts at 9:00:00 am Eastern Time ("ET") on Saturday, August 12, 2023, and ends at 12:00:00 pm ET on Friday, December 29, 2023 (hereafter, the "Promotion Period") and will be divided into nine (9) entry periods (each, an "Entry Period") as indicated in the chart below. All Entry Periods begin at 12:00:00 am ET and end at 11:59:59 pm ET - except for Entry Period 1, which begins at 9:00:00 am ET on Saturday, August 12, 2023.

**3) How to Enter:** During any/all Entry Periods, visit <https://www.panthers.com/fans/terrace-sweeps> and complete and submit the registration form to receive one (1) entry for a maximum of nine (9) entries throughout the Promotional Period. Non-winning entries in each Entry Period will not roll over and will not be included in any subsequent Entry Period. **Limit of one (1) entry per person per Entry Period will be accepted for a maximum of nine (9) entries throughout the Promotion Period. Entries received in excess of the stated limitation will be void.** All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to

enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor's sole discretion and in accordance with these Official Rules) are void. Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, inaccurate, destroyed or undelivered entries, entry information or for telephonic, human or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, emails or the announcement of a prize; or for any injury or damage to entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Sponsor reserves the right, in its sole discretion, to void any entries of entrants who Sponsor believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes or is in violation of these Official Rules.

**4) Winner Selection:** On or about each Drawing Date listed above, two (2) potential First Prize winners will be randomly selected from among all entries received during the respective Entry Period; for a total of twenty (20) potential First Prize winners during the Promotional Period. Odds of winning a prize depend upon the total number of eligible entries received. Limit one (1) prize per person, family, or household. The potential winners will be notified on or around the drawing date. All winners shall be required to respond, within twenty-four (24) hours of the issuance of Notification, as determined by Administrator in its sole and absolute discretion. A winner's failure to respond back to Administrator within the requisite twenty-four (24) hour period shall result in a retraction of the winnings. The potential winners may be required to execute and return an Affidavit of Eligibility, Liability, and (where legal) Publicity Release as well as any other documents required by Administrator within three (3) days of issuance of notification. Non-compliance with the foregoing or with these Official Rules in any way, the inability to contact any potential winner (as specified above), any potential winner's rejection of his or her prize or return of prize or prize notification as non-deliverable may result in disqualification and, at Administrator's discretion, the awarding of the applicable prize by selecting an alternate potential winner in a random drawing from among all remaining eligible entries received.

**5) Prizes:** twenty (20) Prizes will be awarded: two (2) winners shall be chosen for each Entry Period. Each winner shall receive two (2) club-level terrace tickets and two (2) passes to one (1) of the Panthers' premium pregame hospitality areas (i.e., The Panthers Lair). The approximate retail value ("ARV") of each prize is as follows: Preseason – Five Hundred Thirty-Four Dollars (\$534); Regular Season - One Thousand Two Hundred Sixty-Eight Dollars (\$1,268). AVR of all prizes: \$21,356. *Winners*

*shall be responsible for adhering to the applicable tax laws related to gifts in excess of Six Hundred Dollars (i.e. W-9 requirement) and the payment of any and all applicable taxes and fees associated therewith.*
