

2023 Chicago Bears Monsters of the Midway Trading Cards Sweepstakes
OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.

1. HOW TO ENTER: The entry period for 2023 Chicago Bears Monsters of the Midway Trading Card Sweepstakes (the "Sweepstakes") will be conducted throughout the 2023 Chicago Bears regular season between August 28, 2023 at 10:00AM Central Time ("CT") and ends on January 7, 2024 at 11:59PM CT and will be comprised of four (4) separate entry periods (each, an "Entry Period") as follow:

To enter the Sweepstakes log onto <https://www.chicagobears.com/fan-zone/monsters-of-the-midway-trading-cards> and complete the online entry form during the Entry Period. Limit one entry per person per Entry Period ("Entrant").

2. ELIGIBILITY: The Sweepstakes is open to all legal residents of the United States ages 18 years and over as of August 28, 2023, excluding residents of Rhode Island. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc.
