

2023 CHICAGO BEARS GET TO THE GAME SWEEPSTAKES
OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

1. HOW TO ENTER: The 2023 Chicago Bears Get To The Game Sweepstakes (the “Sweepstakes”) starts September 1, 2023 at 10:00AM Central Time (“CT”) and ends on October 8, 2023 at 11:59 PM CT (“Entry Period”). To enter the Sweepstakes, visit www.chicagobears.com/GetToTheGame and complete the entry form by providing your name, address, date of birth, email address, and phone number (“CB.com Entry Form”). Limit one (1) entry per person during the Entry Period. Entrants that use multiple email addresses to enter the Sweepstakes will be disqualified.

2. ELIGIBILITY: The Sweepstakes is open to all legal residents of the contiguous United States ages 18 years and over as of September 1, 2023, excluding residents of Rhode Island. Employees, officers, directors, agents, and representatives of The Chicago Bears Football Club, Inc. (“Sponsor” or “Chicago Bears”), the National Football League, and their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, advertising and promotion agencies, and their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, half-sister) and/or those living in the same household of each are not eligible. All federal, state and local laws and regulations apply. Void where prohibited by law.

3. PRIZE: One (1) prize winner (the “Prize Winner”) will receive the following prizes (collectively, the “Prize”):

- Two (2) tickets to the Chicago Bears vs. New Orleans game on Sunday, November 5, 2023 at the Caesars Superdome in New Orleans, Louisiana

- One (1) night hotel accommodations for Saturday, November 4 (one room for two);
- One (1) Chicago Bears autographed item; and
- Two (2) Chicago Bears hats and two (2) Chicago Bears stadium bags

Approximate retail value of the Prize is \$1,850. Sponsor reserves the right to substitute any part of the Prize with another of equal value should any unforeseen circumstances occur. All state, federal, and local taxes or other expenses not specified herein are the sole responsibility of the Prize Winner, including, without limitation, any costs or expenses associated with travel to and from AT&T Stadium. No substitutions or cash redemption will be made except in Sponsor’s sole discretion. The Prize is non-transferable.

4. SELECTION OF WINNER: The Prize Winner will be selected in a random drawing held on or about October 9, 2023 from among all eligible entries received. The Prize Winner will be notified by email or telephone on or about October 9, 2023. Odds of winning depend upon the number of eligible entries received.

The unavailability of the Prize Winner to be reached after a reasonable (as determined solely by Sponsor) effort has been made may constitute forfeiture of being a Prize Winner, at Sponsor's sole discretion, and a new Winner may be selected from the remaining eligible entries. In addition, if the Prize Winner is selected and subsequently becomes unavailable to receive the Prize and/or attend the Game as set forth in Paragraph 3 above, he/she will be disqualified at Sponsor's sole discretion and a new Prize Winner may be selected from the remaining eligible entries. The Prize Winner must agree and be available to participate in media interviews as determined by Sponsor.

ADDITIONAL DISCLAIMERS: If the Sweepstakes is not capable of running as planned for any reason, including, without limitation, because of a printing error, human error, unauthorized intervention, fraud, technical failure or other cause which corrupt or threaten to corrupt or adversely affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to cancel, modify or suspend the Sweepstakes, including awarding the Prize from among eligible entries received prior to the date of the cancellation, modification or suspension. All entrants, as a condition of entry, agree to abide by and be bound by these Official Rules and the decisions of Sponsor. Failure to comply with these Official Rules may result in disqualification from this Sweepstakes. Sponsor reserves the right to permanently disqualify any person it believes has violated these Official Rules. Entrants further agree to not knowingly damage or cause interruption of the Sweepstakes and/or prevent others from using the Sweepstakes. Any person who supplies false information, obtains entries by fraudulent means, or is otherwise determined to be in violation of these Official Rules in an attempt to obtain the Prize will forfeit the Prize and may be prosecuted to the full extent of the law.
