## 2023 CHICAGO BEARS GET TO THE GAME SWEEPSTAKES OFFICIAL RULES

## NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **2. ELIGIBILITY:** The Sweepstakes is open to all legal residents of the contiguous United States ages 18 years and over as of September 1, 2023, excluding residents of Rhode Island.
