Pit Viper VIP Game Day Sweepstakes

OFFICIAL RULES

On December 21, 2023, drawings for the Prizes will be conducted and a potential winner will be selected. All entries must be received by 9:59 AM Mountain Time on December 21, 2023. Pit Viper's method of timekeeping is the official time clock for the Sweepstakes and is final and undisputable.
- 2. **ELIGIBILITY:** To be eligible to enter, you must be a legal resident of the State of Florida and be at least eighteen (18) years of age at the time of entry. **VOID WHERE PROHIBITED BY LAW**. If you enter online, you will also be required to provide certain content, as further described at the time of your submission. LIMIT ONE (1) ENTRY PER PERSON.

Any attempt to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void such entries and that entrant may be disqualified. - 5. **DRAWING:** On December 21, 2023 on or around 12:00 PM Mountain Time, Pit Viper will conduct a virtual drawing and randomly draw one (1) entry from among all eligible entries received.
